**Actual Procedure:** Well spud on 4/6/2022 at 09:00 4/6/2022: Drill 17.5 inch surface hole to 1090 ft. Run 13.375 inch 54.5 lb J55 surface casing to 1075 ft. Pump 20 bbls freshwater, followed by 430 sks of 13.5 ppg lead cmt, 550 sks of 14.8 ppg tail cmt. Drop plug and displace with 160 bbls freshwater. 110 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. Surface Casing Details: Casing ran: 4/6/2022, Fluid Type Fresh Water, Hole 17.5 inch, Csg Size 13.375 inch, Weight 54.5 lbs, Grade J55, Est TOC 0 ft, Depth set 1075 ft, Cement 970 sacks, Yield 1.71 lead/1.33 tail, Class C.
