Procedure Description: he procedure for the MIT will be as follows: Move in pumping equipment. Hook up to the well with pump and chart recorder. Pressure the well up to 500 psi, secure pumping and record pressures for 30 minutes. Blow down and secure well. Results will be forwarded to the BLM office in Roswell with copies to Las Cruces BLM and NMOCD. If the well fails the MIT, repairs will be designed and after approval of repairs by the BLM, a workover rig will be mobilized to undertake repairs. Equipment for the MIT can be mobilized to the well location within three weeks of Sundry approval.
