Pump 20 bbls freshwater, followed by 430 sks of 13.5 ppg lead cmt, 550 sks of 14.8 ppg tail cmt. Drop plug and displace with 160 bbls freshwater. 115 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
