Actual Procedure: Spud Well @ 2:45PM 10-19-2022. Drill 17 ½" hole to 385'. Ran 10 jts of 13 3/8" 54.5# BTC to 385'. Pumped 30 bbl FW spacer followed by 500 sks (118 bbl) 14.8 ppg class C cement. 101 sks (24bbls) to surface. WOC 8 hours. Install well head and BOP, test 250 low and 3000 high for 10 min. Test casing to 1500psi for 30 min. Good tests. Drill 12 ¼" hole to 1265'. Run 30 jts 9 5/8" 36# J-55 to 1263'. Pump 30 bbls FW spacer. Pump 395 sks (121 bbls) 13.5 ppg 1.72 yield lead cement. Pump 165 sks (39 bbls) 14.8 ppg 1.33 yield class C tail cement. 1.5 sks (1/2 bbls) to surface. WOC for 4 hours, test casing to 1500psi, good test. Drill 8 ¾" hole to 7032'. Drill pipe got stuck in the horizontal section. Received BLM approval to sidetrack. Sidetrack will be drilled 25' North and 25' deeper than original permitted location. TD is at 7,032'MD. Top of fish is at 4,106'MD. Pumped 56 bbls Class H 17.5 ppg cement from 3210'. WOC 15.5 hours. TIH to 3510', no cement, no losses or gas shows. Pump 59 bbls class C cement from 3204'. WOC 15.5 hours. TOC @ 2874'. Drill sidetrack 8 ¾" hole from 2,905' to 9,370'. Run 109 jts of 5 ½" 20# HCL80 to 7" crossover and 112 jts of 7" 32# HCL80 to 9362'. Crossover at 4,435'. Pump 30 bbl FW spacer. Pump 460 sks (177 bbl) 12.2 ppg 2.16 yield 25/75 Poz class C lead cement. Pump 1035 sks (245 bbl) 14.8 ppg 1.33 yield tail cement. Bumped plug. 153 sxs (59 bbls) to surface.
