1. Hold pre-job safety meeting. Comply with all **NMOCD**, **BLM**, and HEC safety and environmental regulations. Notify NMOCD and BLM 24 hours prior to MIT and get witnesses on location for test if necessary. Record pressures across all strings.

2. RU pump truck. Load casing, as necessary. Perform MIT against plug at 1733' to 560 psi for 30 minutes on a 2 hour chart with a 1000 lb spring. SI well. RD pump truck. Send MIT into regulatory.

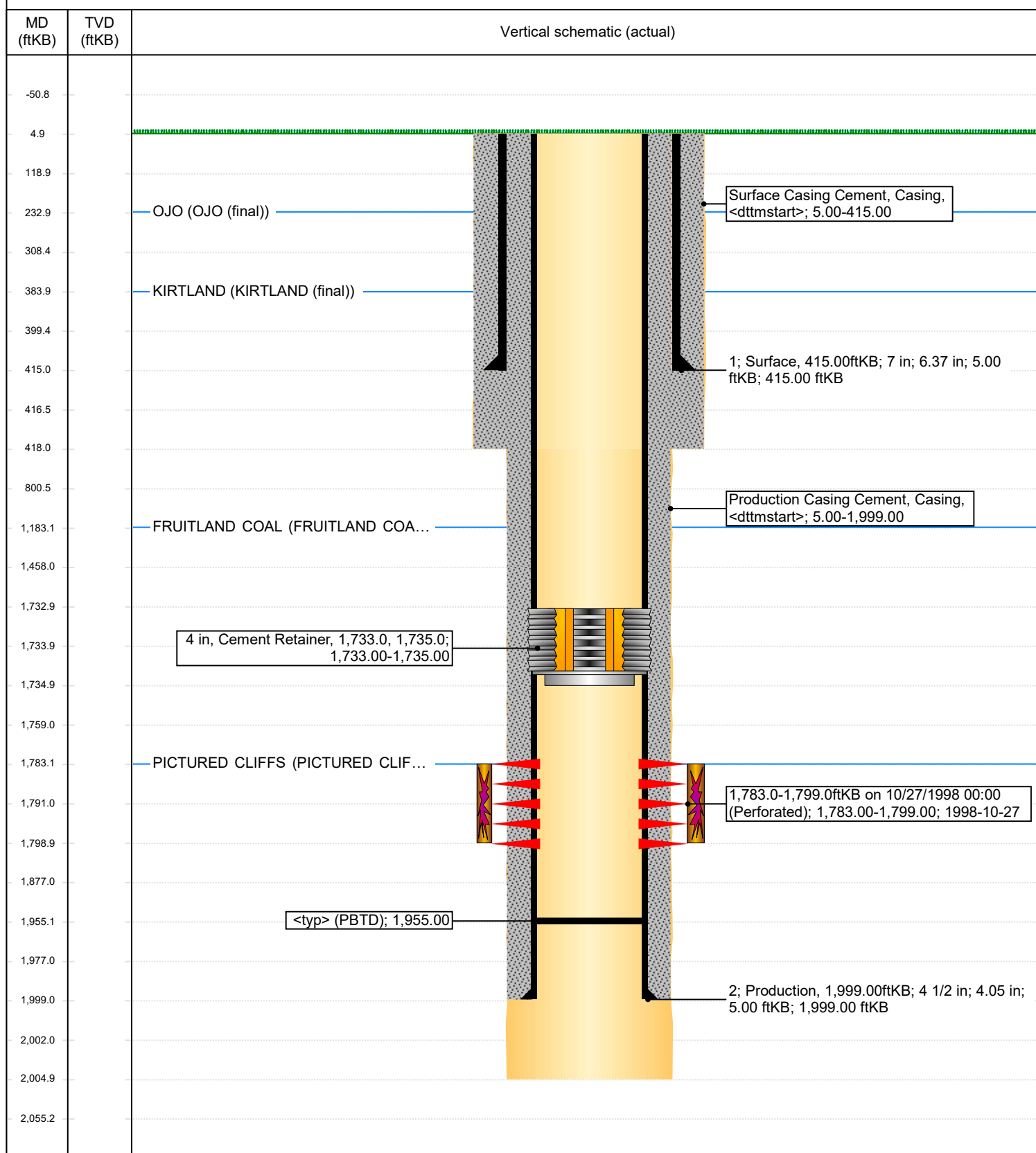


## Current Schematic - Version 3

2. Also after work is completed, send in a Sundry Notification – Notice of Intent (SN-NOI) requesting (or renewing) temporary abandonment status. Note approval is still based on the discretion of this agency. This request must be submitted within 30 days after work is completed.  
  
Include in the SN-NOI the following:
  - a. Proposed exact expiration date (month, day, year). Can not be greater than 12-months from date of submission. The date can also be when the current TA approval will expire.
  - b. Confirmation of other production on lease, or agreement.
  - c. Plans for the well.
3. This agency reserves the right to modify or rescind approval. A plug or produce order may still be issued at the discretion of the authorized officer.
