Figure 1 – Current Wellbore Diagram

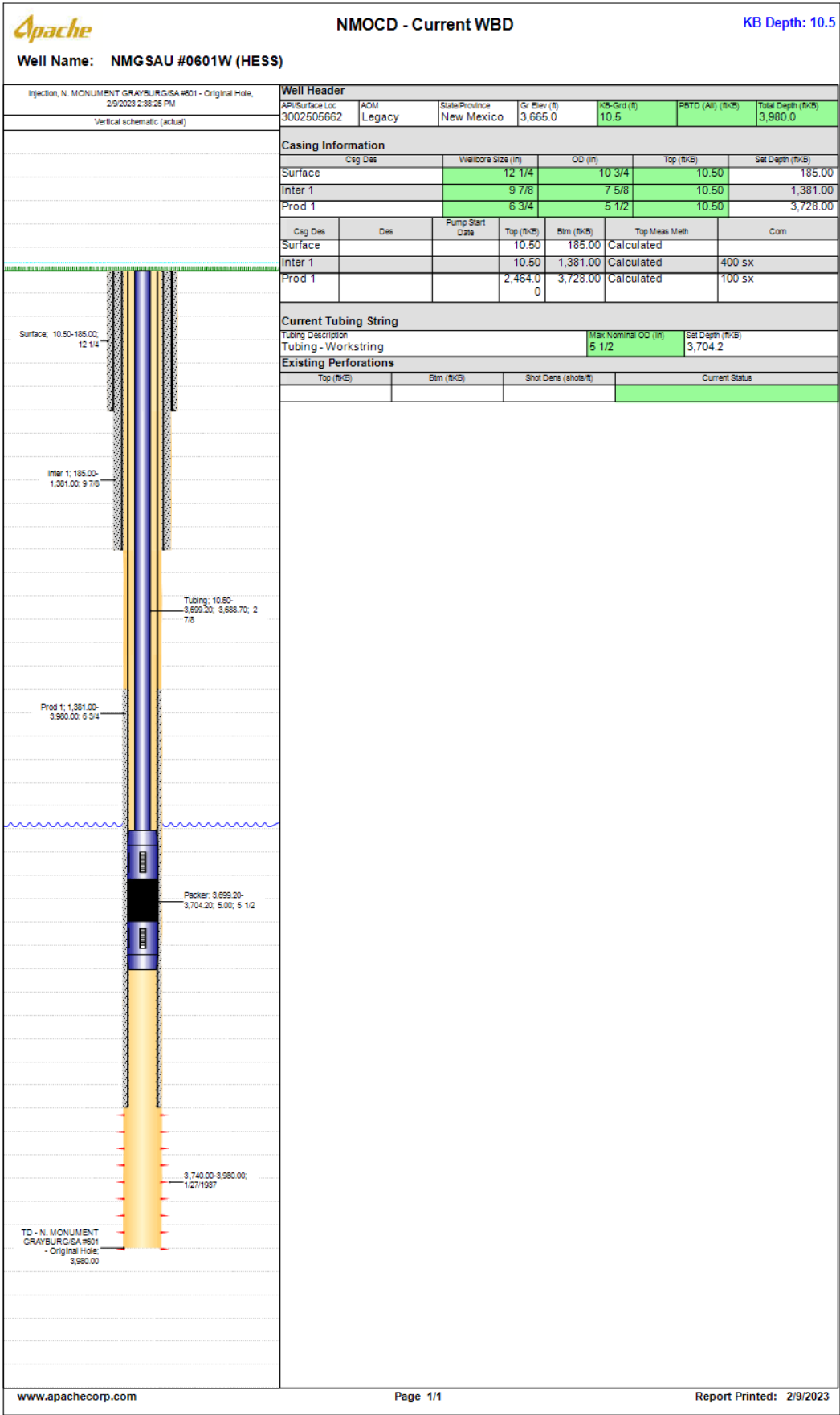
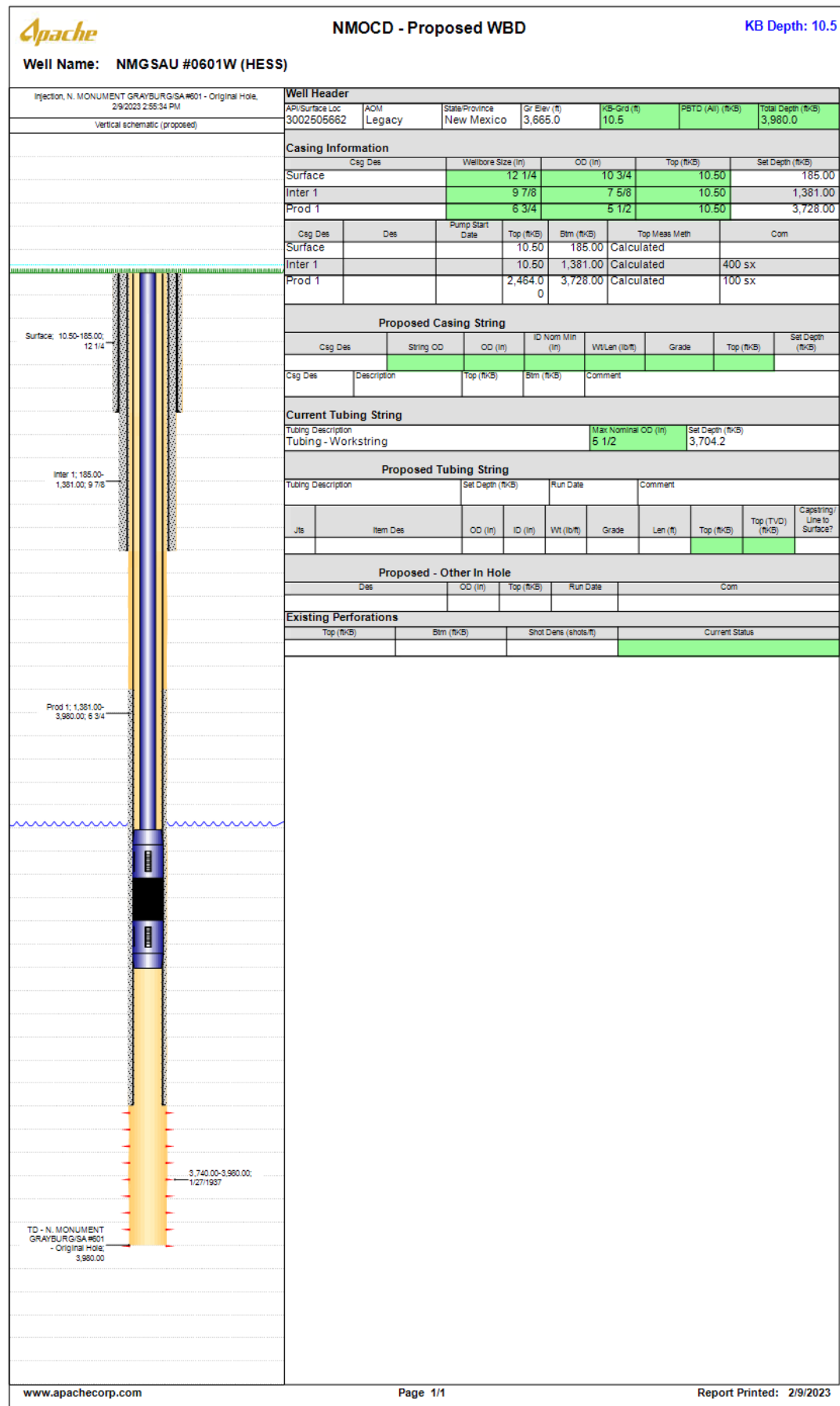


Figure 2 – Proposed Wellbore Diagram
