This extension is necessary in order to service depletion that required EOG to prioritize the development in the 2nd Bone Spring formation and delay the development of the 1st Bone Spring and Wolfcamp targets. Otherwise, the simultaneous development and production of all formations would exceed infrastructure capacities and likely result in the need to flare gas and/or truck oil and water.
