Actual Procedure: Following an unsuccessful plug bump on Int 1 first stage, we performed a full casing test above the DV tool for 30 mins at 1500 psi but was unable to get a full test below the DV. Received verbal from Mandela Kamau to proceed forward with updated plan to bring production cement to ~400' above the DV tool. Below are the proposed cement volumes and yields.
