**Plugging Report
Scharb 9 #2
API 30-025-28195**

1/30/2023 Moved in rig, set matting board, and rigged up. Removed the fence on the west side of location to make room for equipment. Pump was stuck. Worked free and started laying down the rods. Laid down 90 ¾" rods and SION.

1/31/2023 Finished laying down the rods. 378 ¾" rods and 7 sinker bars. Installed BOP and released the anchor. SION

2/1/2023 Shut down for weather.

2/2/2023 POOH with tubing. 298 joints of 2 3/8" tubing. Anchor was 4 stands above the S/N. Set 5.5" CIBP at 9398'. Collar at 9388'. RIH with tubing and tagged CIBP. Circulated MLF and tested casing. Good to 525#. Spot 25 sx Class H cement on top of CIBP. POOH 15 stands and SION.

2/3/2023 POOH with tubing. Perforated casing at 6388'. Set packer and pressured up to 750# and held. POOH with packer and RIH with tubing. Spot 25 sx cement across perforations from 6439'. POOH and SION.

2/6/2023 Tagged cement at 6198'. Perforated at 4050'. Set packer and established rate. Good communication with intermediate head. Squeezed with 40 sx cement with CaCl. WOC and tagged at 3903'. POOH and perforated at 1900'. Set packer and squeezed with 30 sx cement. Left packer set and SION.

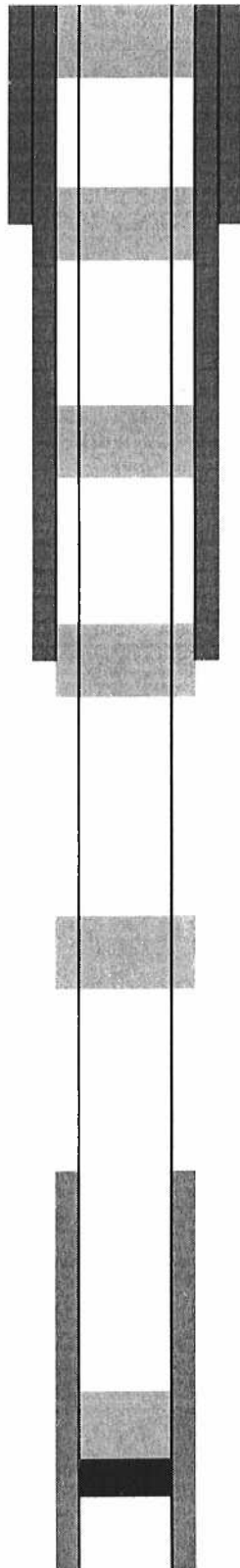
2/7/2023 Tagged cement at 1755'. Lay down remaining tubing and perforated casing at 467'. Pump cement down the 5 ½" to perforations and up the intermediate annulus to surface took 120 sx. Rig down, dig out and remove the wellhead. Good cement in the 5 ½" and 8 5/8". Fill up 13 3/8" with 5 sx cement. Installed standard marker, cleaned the pit and removed the anchors.
