


San Juan 27-5 Unit 144 - CURRENT WELLBORE SCHEMATIC

CONDITIONS OF APPROVAL FOR PROPOSED WORK TO TEMPORARY ABANDONED

1. After work is completed, send in Sundry Notification – Subsequent Report detailing actual work completed with exact dates (month, day, year). And the updated wellbore schematic. The report must be submitted within 30 days after work is completed.
2. Also after work in completed, send in a Sundry Notification – Notice of Intent (SN-NOI) requesting (or renewing) temporary abandonment status. Note approval is still based on the discretion of this agency. This request must be submitted within 30 days after work is completed.

Include in the SN-NOI the following:
 - a. Proposed exact expiration date (month, day, year). Can not be greater than 12-months from date of submission. The date can also be when the current TA approval will expire.
 - b. Confirmation of other production on lease, or agreement.
 - c. Plans for the well.
3. This agency reserves the right to modify or rescind approval. A plug or produce order may still be issued at the discretion of the authorized officer.
