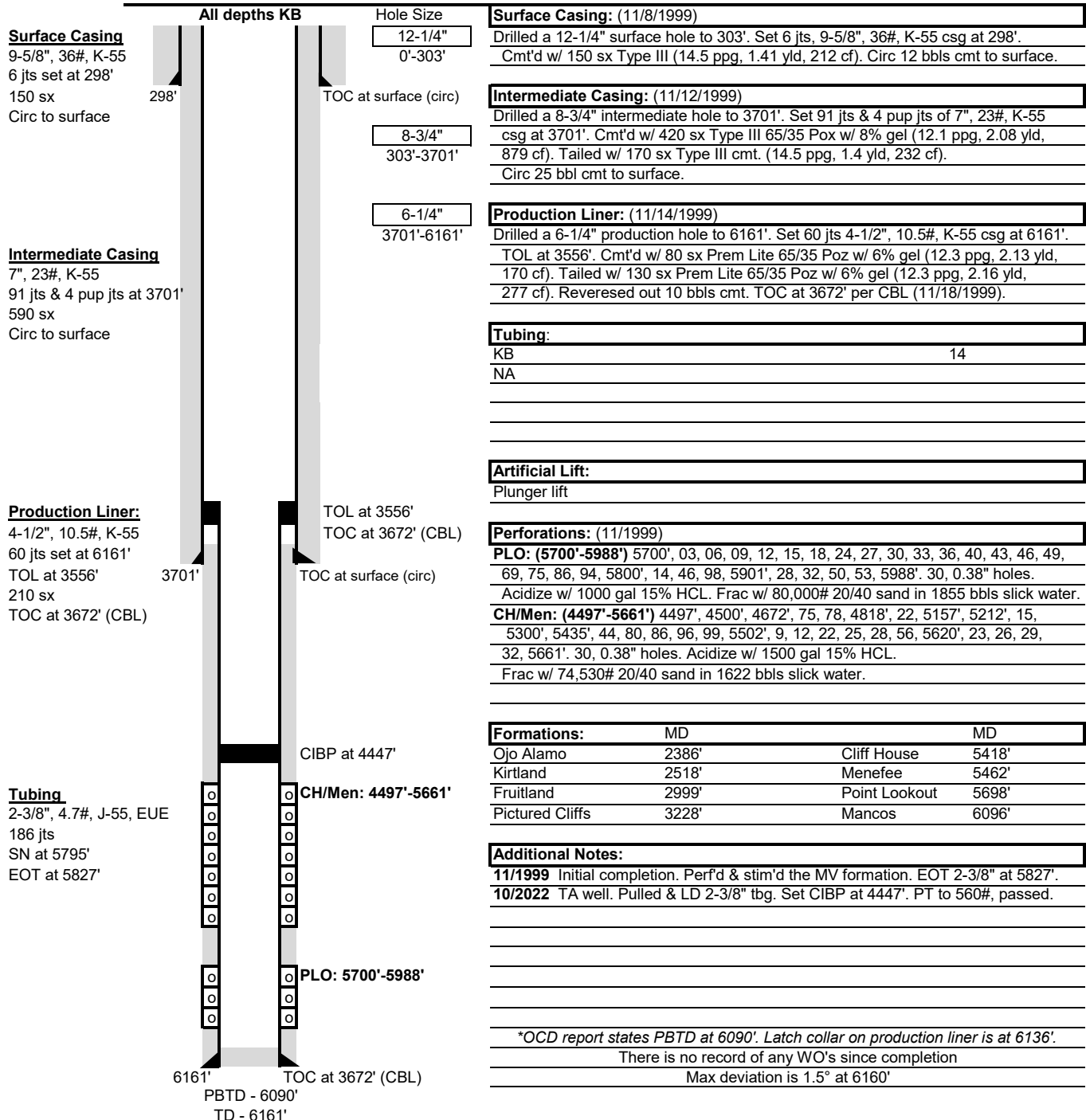


Wellbore Schematic
