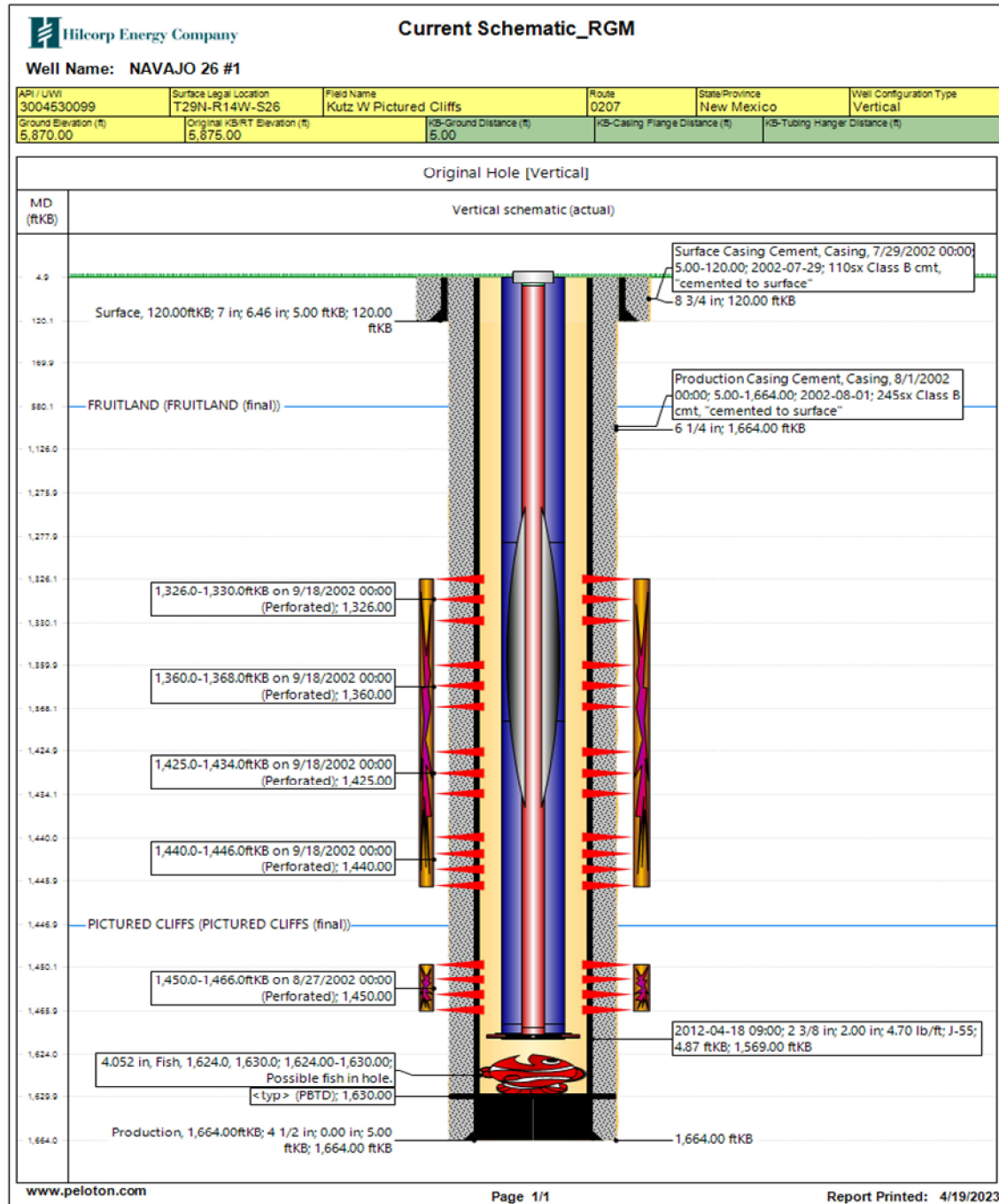
JOB PROCEDURES

- ☒ NMOCD **Contact OCD and BLM/Navajo 24 hrs prior to MIRU. Comply with all NMOCD, BLM & Navajo, and HEC safety and**
- ☒ BLM/Navajo **environmental regulations.**
1. MIRU service rig and associated equipment, remove drive head, prep to pull rods. Record all casing pressures on well.
 2. Unseat rotor, POOH w/ rotor on rods, lay down.
 3. Load well, ND tree, NU BOPs and test.
 4. POOH w/ 2-3/8" production tbg & stator, lay down.
 5. MU 4-1/2" 10.5# bit/scraper, clear csg to 1,290', POOH. RIH w/ 4-1/2" 10.5# CICR on pipe and set @ 1,276' (FRD Top Perf 1,326).
 6. **Plug #1a | 1,276' - 1,466' (PC Top @ 1,447' | FRD Top Perf 1,326')** Mix and pump 25sx (6.1 bbl) Class III Select cmt below CICR to cover FRD perms & PC Top - volume includes 100% excess. Sting out, reverse circulate tubing clean.
 7. Pressure test 4-1/2" & CICR to 560psi for 30min.
 8. **Plug #1b | 1' (FRD Top 590')** Circulate in & spot a 150' cmt plug [16sx (3.9 bbl) Class III Select] above the CICR to cover the FRD Top. PU, reverse circulate tubing clean.
 9. **Plug #2 | Surface - 170' (Surface shoe: 120')** Circulate in 25sx (6.1 bbl) Class III Select cmt from 170' to surface to cover shoe.
 10. LD tubing. ND BOP and cut off wellhead below surface casing flange as per NMOCD. Top off cement at surface as needed. Weld new P&A maker.
- Note** Class III "Select" cement: Neat, 1.37yld, 14.6ppg, 6.64gpsx mix wtr.

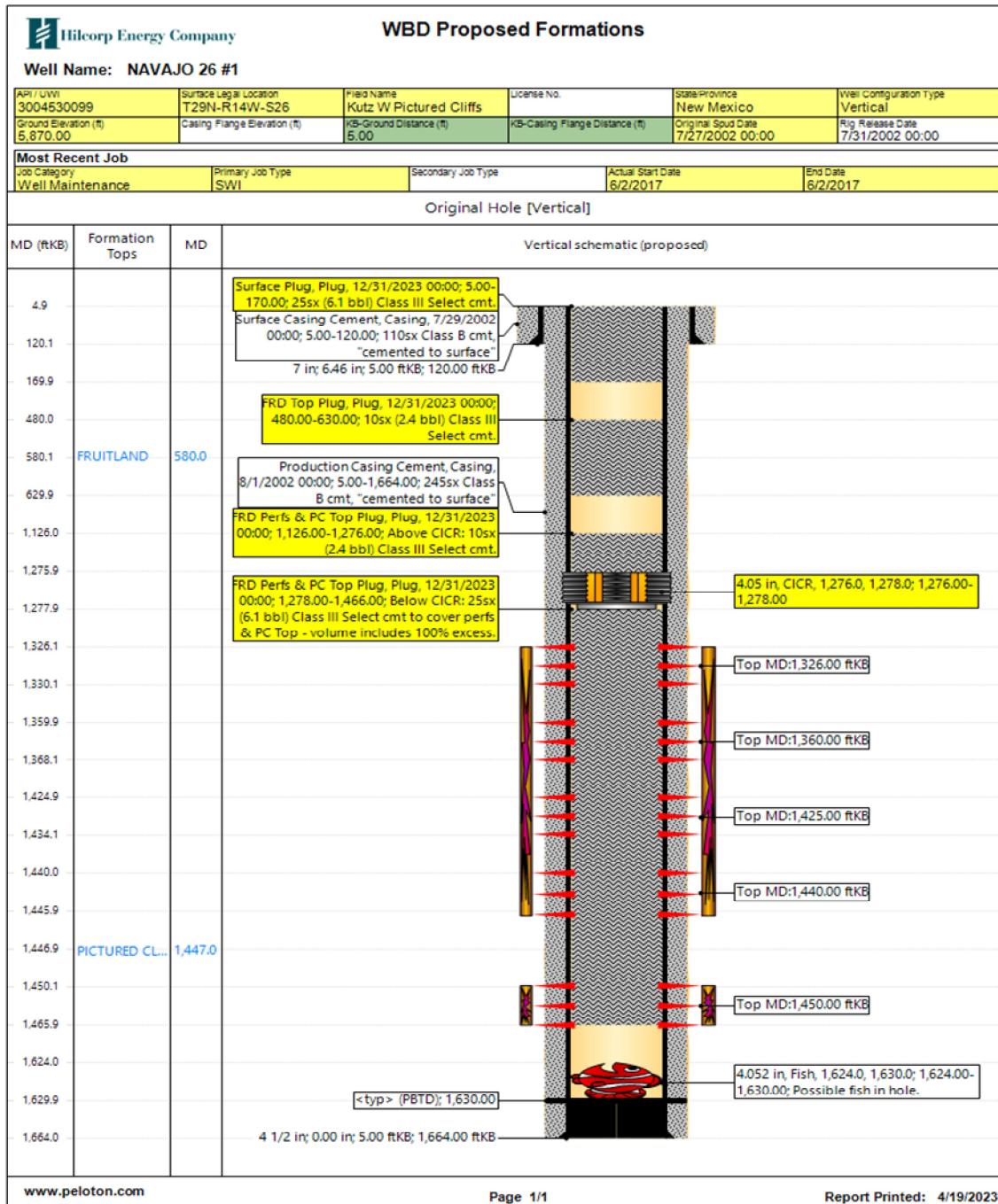
NAVAJO 26 1 - CURRENT WELLBORE SCHEMATIC

1. PRE-RECLAMATION SITE INSPECTION

1.1) A pre-reclamation site inspection was completed by Hilcorp Energy and representatives from multiple government agencies on Tuesday June 6, 2023:

- Roger Herrera with the BLM
- Bertha Spencer with the BIA
- Belinda Chee with the Navajo Nation
- Johnnie Begay with the Navajo Nation
- Valjean Uentillie with the Navajo Nation
- Chad Perkins with Hilcorp Energy

2. LOCATION RECLAMATION PROCEDURE

- 2.1) Final reclamation work will be completed after the well is Plugged.
- 2.2) Remove all production equipment, anchors, and flowlines.
- 2.3) The water and gas pipelines will be stripped from the well facility to the dogleg or mainline. The mainline will be blind flanged or capped off.
- 2.4) The lease access road that runs through the center of the well pad it will not be closed since it is access to pipeline risers and pipeline ROW.
- 2.5) All nonnative aggregate will be scraped up and buried in toe of the cut prior to re-contouring.
- 2.6) On the southeast side of the lease access road the fill will be pushed into the cut slope and re-contoured with shallow swales and or silt traps for major drainage to create a rolling terrain that matches natural topography drainage features to limit erosion.
- 2.7) On the northwest side of lease access road, the soil will be rolled off to the north reducing the slope. It will be re-contoured with shallow swales and or silt traps for major drainage to create a rolling terrain that matches natural topography drainage features to limit erosion.
- 2.8) Rip compacted soil and walk down disturbed portion of well pad.
- 2.9) All trash and debris will be removed within 50' buffer outside of the location disturbance during reclamation.

3. ACCESS ROAD RECLAMATION PROCEDURE:

- 3.1) The lease access road that runs through the center of the well pad it will not be closed since it is access to pipeline risers and ROW.
- 3.2) All trash and debris will be removed within 50' buffer outside of the road disturbance during reclamation.

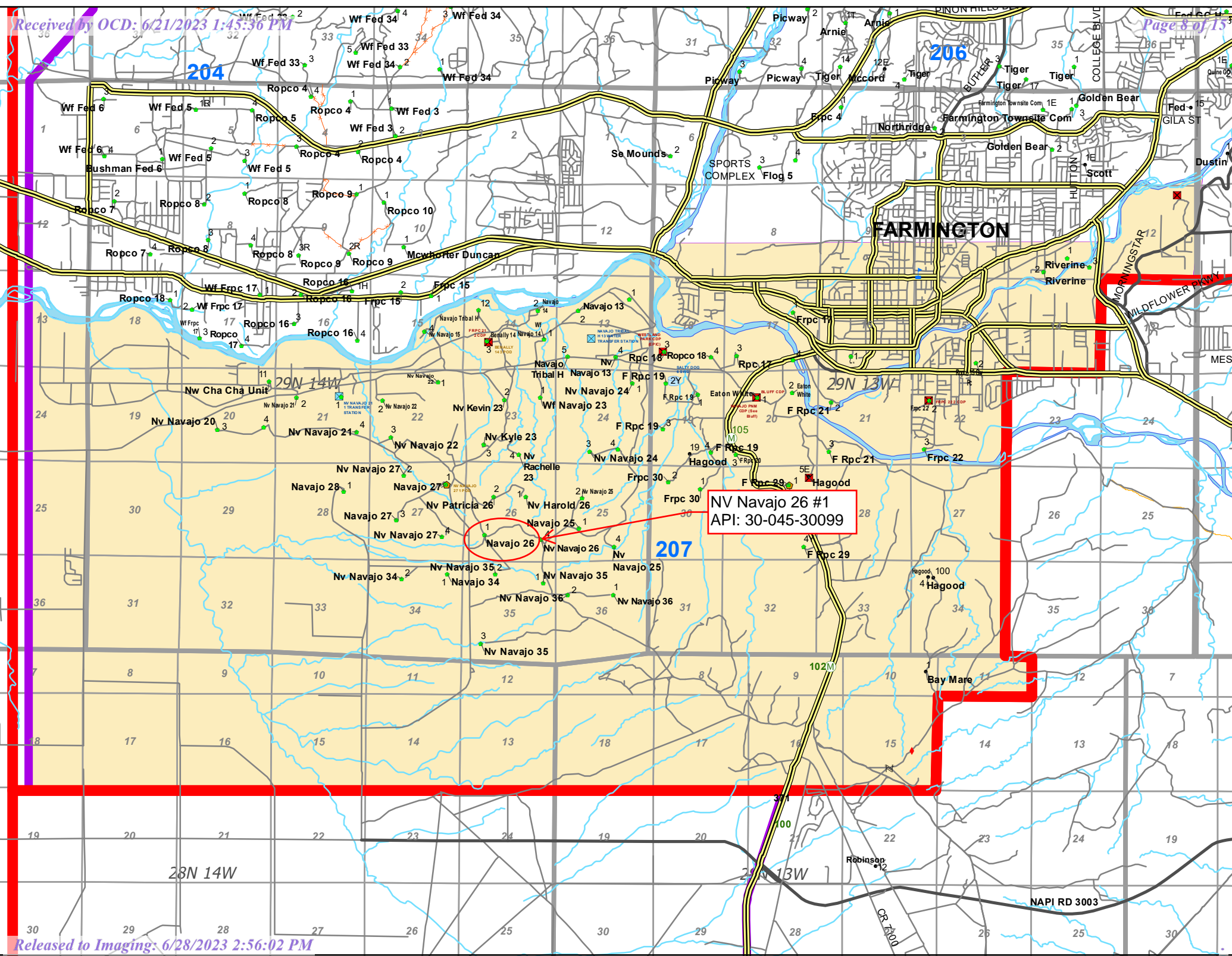
4. SEEDING PROCEDURE

- 4.1) A Pinon/Juniper seed mix will be used for all reclaimed and disturbed areas of the location and lease road.

- 4.2) Drill seeding will be done where applicable and all other disturbed areas will be broadcast seeded and harrowed, broadcast seeding will be applied at a double the rate of seed.
- 4.3) Timing of the seeding will take place when the ground is not frozen or saturated.

5. WEED MANAGEMENT

- 5.1) No action is required at this time for weed management, no noxious weeds were identified during the onsite.

**GENERAL REQUIREMENTS FOR
PERMANENT ABANDONMENT OF WELLS ON FEDERAL AND INDIAN LEASES
FARMINGTON FIELD OFFICE**

1.0 The approved plugging plans may contain variances from the following minimum general requirements.

1.1 Modification of the approved plugging procedure is allowed only with the prior approval of the Authorized Officer, Farmington Field Office.

1.2 Requirements may be added to address specific well conditions.

2.0 Materials used must be accurately measured. (densometer/scales)

3.0 A tank or lined pit must be used for containment of any fluids from the wellbore during plugging operations and all pits are to be fenced with woven wire. These pits will be fenced on three sides and once the rig leaves location, the fourth side will be fenced.

3.1 Pits are not to be used for disposal of any hydrocarbons. If hydrocarbons are present in the pit, the fluids must be removed prior to filling in.

4.0 All cement plugs are to be placed through a work string. Cement may be bull-headed down the casing with prior approval. Cement caps on top of bridge plugs or cement retainers may be placed by dump bailer.

4.1 The cement shall be as specified in the approved plugging plan.

4.2 All cement plugs placed inside casing shall have sufficient volume to fill a minimum of 100' of the casing, or annular void(s) between casings, plus an excess volume sufficient to provide for 50 linear feet of fill above the plug.

4.3 Surface plugs may be no less than 50' in length.

4.4 All cement plugs placed to fill annular void(s) between casing and the formation shall be of sufficient volume to fill a minimum of 100' of the annular space plus 100% excess, calculated using the bit size, or 100' of annular capacity, determined from a caliper log, plus an excess volume sufficient to provide for 50 linear feet of fill above the plug.

4.5 All cement plugs placed to fill an open hole shall be of sufficient volume to fill a minimum of 100' of hole, as calculated from a caliper log, plus an excess volume sufficient to provide for 50 linear feet of fill above the plug. In the absence of a caliper log, an excess of 100% shall be required.

4.6 A cement bond log or other accepted cement evaluation tool is required to be run if one had not been previously ran or cement did not circulate to surface during the original casing cementing job or subsequent cementing jobs.

5.0 All cement plugs spotted across, or above, any exposed zone(s), when; the wellbore is not full of fluid or the fluid level will not remain static, and in the case of lost circulation or partial returns during cement placement, shall be tested by tagging with the work string.

- 5.1 The top of any cement plug verified by tagging must be at or above the depth specified in the approved plan, without regard to any excess.
- 5.2 Testing will not be required for any cement plug that is mechanically contained by use of a bridge plug and/or cement retainer, if casing integrity has been established.
- 5.3 Any cement plug which is the only isolating medium, for a fresh water interval or a zone containing a prospectively valuable deposit of minerals, shall be tested by tagging.
- 5.4 If perforations are required below the surface casing shoe, a 30 minute minimum wait time will be required to determine if gas and/or water flows are present. If flow is present, the well will be shut-in for a minimum of one hour and the pressure recorded. Short or long term venting may be necessary to evacuate trapped gas. **If only a water flow occurs with no associated gas, shut well in and record the pressures. Contact the Engineer as it may be necessary to change the cement weight and additives.**

6.0 Before setting any cement plugs the hole needs to be rolled. All wells are to be controlled by means of a fluid that is to be of a weight and consistency necessary to stabilize the wellbore. This fluid shall be left in place as filler between all plugs.

- 6.1 Drilling mud may be used as the wellbore fluid in open hole plugging operations.
- 6.2 The wellbore fluid used in cased holes shall be of sufficient weight to balance known pore pressures in all exposed formations.

7.0 A blowout preventer and related equipment (BOPE) shall be installed and tested prior to working in a wellbore with any exposed zone(s); (1) that are over pressured, (2) where the pressures are unknown, or (3) known to contain H₂S.

8.0 Within 30 days after plugging work is completed, file a Sundry Notice, Subsequent Report of Abandonment (Form 3160-5), through the Automated Fluid Minerals Support System (AFMSS) with the Field Manager, Bureau of Land Management, 6251 College Blvd., Suite A, Farmington, NM 87402. The report should show the manner in which the plugging work was carried out, the extent, by depth(s), of cement plugs placed, and the size and location, by depth(s), of casing left in the well. Show date well was plugged.

9.0 All permanently abandoned wells are to be marked with a permanent monument as specified in 43 CFR 3162.6(d). Unless otherwise approved.

10.0 If this well is located in a Specially Designated Area (SDA), compliance with the appropriate seasonal closure requirements will be necessary.

All of the above are minimum requirements. Failure to comply with the above conditions of approval may result in an assessment for noncompliance and/or a Shut-in Order being issued pursuant to 43 CFR 3163.1. You are further advised that any instructions, orders or decisions issued by the Bureau of Land Management are subject to administrative review pursuant to 43 CFR 3165.3 and appeal pursuant to 43 CFR 3165.4 and 43 CFR 4.700.
