



Separation Equipment

Premier Oil & Gas, Inc. has significant development on the Dale H. Parke A Tract 1 lease both in the Yeso and San Andres formations and has ample data for sizing equipment that has been time tested for several decades in the Loco Hills area. A gas gathering system is already present on the lease at the Dale H. Parke A Tract 1 #15 well site facility where the #23 oil, gas, and water is already plumbed to.

Premier will use the following equipment for developing the [28509] GRYB-JCKS-7-RVS-QN-GB-SA in the Dale H. Parke A Tract 1 #23 well:

 A 6 x20 three phase separator will be used for this well and will feed into a 75 psi heater treater to separate oil and water. Fluids are sent to their respective tanks. The separated gas will be sent to the sales line.

Operational Practices

19.15.27.8 (A) Venting and Flaring of Natural Gas

Premier Oil & Gas, Inc. understands the requirements of NMAC 19.15.27.8 which states that the venting and flaring of natural gas during drilling, completion, and production that constitutes waste as defined in 19.15.2 are prohibited.

19.15.28.8 (C) Venting and Flaring during recompletion

The Dale H. Parke #18 is already tied into a site facility and an onsite gas gathering system. This well will be ready on day 1 of flowback and cleanout. See equipment above.

Premier does not anticipate the formation gas will not meet quality standards for processing as we have existing wells already producing from the formation on lease. Should this happen that the well does not meet quality standards. Then a temporary flare will be installed with an automatic igniter. Premier will monitor and route the gas as soon as possible upon it meeting quality and pipeline standards.

19.15.27.8 (D) Venting and flaring during production operations.

Premier will not vent or flare natural gas except under the following circumstances:

- 1) During an emergency or malfunction
- 2) During the following activities unless prohibited
 - a. Gauging or sampling storage tanks or other low-pressure production vessel
 - b. Loading out liquids from a storage tank
 - c. Repair and maintenance
 - d. Normal operation of a gas activated pneumatic controller or pump
 - e. Normal operation of a storage tank

f. Commissioning of pipelines, equipment, or facilities only for as long as necessary to purge introduced impurities.

19.15.27.8 (E) Performance standards

Premier will conduct an inspection on all site facility equipment for leaks or defects daily. Premier will use automated monitoring technology to detect leaks and releases in lieu of any inspections and will resolve any emergencies as promptly as possible.

19.15.27.8 (F) Measure or estimation of vented and flared natural gas

Premier will estimate venting and flared volumes of natural gas from storage tanks and pneumatics using equations from AP-42 Section 7. Premier will install measuring equipment whenever the NMOCD determines that metering is necessary.

Best Management Practices

During completion operations, operator will not produce oil or gas but will maintain well control through the procedure. The well will not be flowed back until all flowlines are tied into existing equipment at the lease site facility. Premier will use automatic gauging systems to reduced venting of natural gas. Premier will shut in wells (where feasible) in the event of a takeaway disruption, emergency situation, or other operations where venting or flaring may occur due to equipment failures.
