## CONDITIONS OF APPROVAL FOR APD EXTENSION

The Approved Application for Permit to Drill (AAPD) expires if only conductor or surface casing has been set, and the well is not being diligently drilled at the expiration date of the extension.

The APD extension is granted for a 2-year period, not exceed 4 years from the approval of the APD.

### **SPECIAL REQUIREMENT(S)**

#### Special Status Plant Species:

Prior to initiating project construction activities, a barricade in the form of temporary fencing for the protection of three Scheer's Beehive Cactus individuals must be installed.

For the protection of known SSPS occurrences, a third-party bio monitor will be required to monitor vehicle activity while project-related surface disturbing activities are being conducted.

Vehicles and equipment must be kept on existing roads and approved surfaces only and must avoid travel across undisturbed surfaces; workers will be instructed not to park off the roads or ROW in undisturbed areas. Alterations to project design and additions of project components will require SSPS surveys and re-analysis of impacts if those project elements intersect SSPS suitable habitat.
