Pump 20 bbl gel spacer, followed by 490 sks of 13.5 ppg tail cmt. Drop plug and displace with 95 bbls freshwater. 82 bbls of cement returned back to surface with top job. EST TOC at 0 ft. Pressure test casing to 1500 PSI for 30 minutes, good test. 4/13/2023: Test BOPS. Drill 9.875 intermediate hole to 12095 ft. 4/20/2023: Run 7.625 inch 29.7 lb L-80 intermediate casing to 12057 ft. Pump 30 bbls fresh water, followed by 925 sks of 10.5 ppg lead cmt, 325 sks of 14.5 ppg tail cmt. Drop plug and displace with 512 bbls of Enerlight then 20 bbls fresh water. 230 bbls cement to surface. EST TOC at 0 ft.
