5. Repair source of leak.
6. RIH with injection packer and set at a depth of ~5776'.
7. Circulate packer fluid and perform MIT. Notify NMOCD 48 hours prior to test.



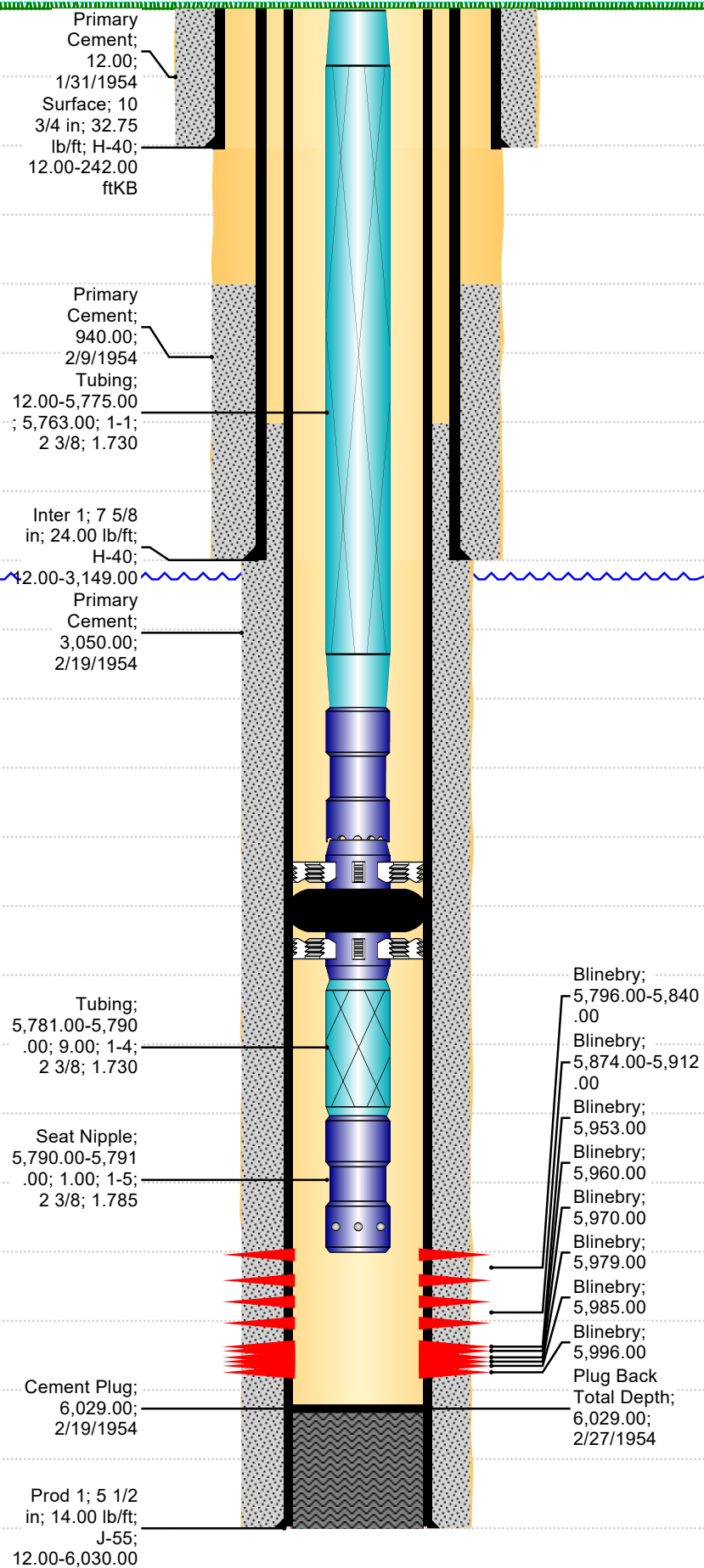
