

- 1. Set blanking plug in packer and test tubing.
- 2. If tubing leak, POOH with tubing and replace.
- 3. If tubing held, POOH with tubing.
- 4. RIH with work string and packer. Confirm well failed MIT due to packer leak or hole in casing.
- 5. Repair source of leak.
- 6. RIH with injection packer and set at a depth of ~5776'.
- 7. Circulate packer fluid and perform MIT. Notify NMOCD 48 hours prior to test.
