Respectfully requests permission to change our drill plan due to issues we have had while drilling, we request that we are able to drill blind from +/- 3000' to +/- 5015' with produced water while keeping the hole full with brine on the backside in the event we see the same loss zone at 3500' like we did on the previous 3 Avogato wells that are being P&A'd due to this same issue. This gives us the ability to successfully drill and case off the salt section which in turn will allow us to drill the second deep intermediate without losses while having the salt section cased off.
