This extension is necessary so as to maintain production volumes within infrastructure limits and prevent gas flaring and/or trucking of oil and water, therefore EOG has delayed the development of additional targets within the Wolfcamp. Nevertheless, EOGs drilling plan reflects timely development of these additional targets which is critical to prevent waste of the minerals.

EOG's goal is to spud these wells by January 31, 2024.
