Thrasher 33 Fed Com 711H 30-025-48400

This extension is necessary because the simultaneous development and production of all formations would exceed infrastructure capacities and potentially resulting in the need to flare gas and truck produced oil and water. Additionally, the development and utilization of these permits has been staggered in order to assess the reservoir quality for the best possible multi-zone development. Recent well results suggest that optimal development of this stratigraphic column to harvest the most minerals and reduce waste will require supplemental permits.

EOG's goal is to spud this well by December 30, 2023.
