This extension is necessary as a result of prioritized development of the Wolfcamp formation to best service depletion, thus delaying the development of the Bone Spring. Otherwise, the simultaneous development and initial production of the two formations would have exceeded infrastructure capacities and potentially resulted in the need to flare gas and/or truck oil and water.

EOG's goal is to spud this well by February 28, 2024.
