Spinnaker cmt w/325 sks Class C Neat (yd @ 1.33 cuft/sk @ 14.8 PPG). Displaced w/49 bbls of FW. Plug down @ 3:30 P.M. 02/09/22. Circ 126 sks of cmt to the pit.
