Cement stage 1 with 275sx lead 11.5ppg 2.3yld 50/50 POZ C and 225sx tail 14.8ppg 1.33yld Class C. Circulate 60bbbls cement off of ECP. Stage 2 with 3500sx lead 11.5ppg 2.26yld 50/50 POZ C and 155sx tail 14.8ppg 1.33yld Class C. Circulate 745sx to surface.
