This extension is necessary because the simultaneous development and production of all formations would exceed infrastructure capacities and potentially result in the need to flare gas and truck produced oil and water. Additionally, the development and utilization of this and other Banjo 5 Fed Com permits has been staggered in order to assess the reservoir quality for the best possible multi-zone development. EOG's goal is to spud this well by April 30, 2024.
