The request to extend the temporary abandonment (TA) is approved with the following conditions:

1. No well shall be TA without prior approval from the authorized officer or representative.
2. This approval is granted for a 12-month period until June 14, 2024. **Before this approval expires** one of the following shall be submitted:
 - a. A sundry notice (Notice of Intent - Recompletion) to recomplete the well into the Mesa Verde detailing the work to be done. A Communitization Agreement covering the acreage dedicated to the well must be filed for approval with the Bureau of Land Management, New Mexico State Office, Reservoir Management Group, 301 Dinosaur Trail, Sante Fe, NM 87508. The effective date of the agreement must be **prior** to any sales.
 - b. A sundry notice (Notification – Resume Production) with resumption of production reported.
 - c. A sundry notice (notice of intent) to plug and abandon (P&A) the well. While not necessary to P&A before June 14, 2024, a sundry notice must be submitted prior to that date.
 - d. No further Notice of Intent - Temporary Abandonment will be approved without significant engineering, geologic, and/or economic justification for future beneficial use of the well.
3. This agency reserves the right to modify or rescind approval. A plug or produce order may still be issued at the discretion of the authorized officer.
4. The lease is currently held by production from other wells. Should production from the lease cease, the BLM will require this well be returned to production or P&A, regardless of the amount of time the TA status is still approved for.

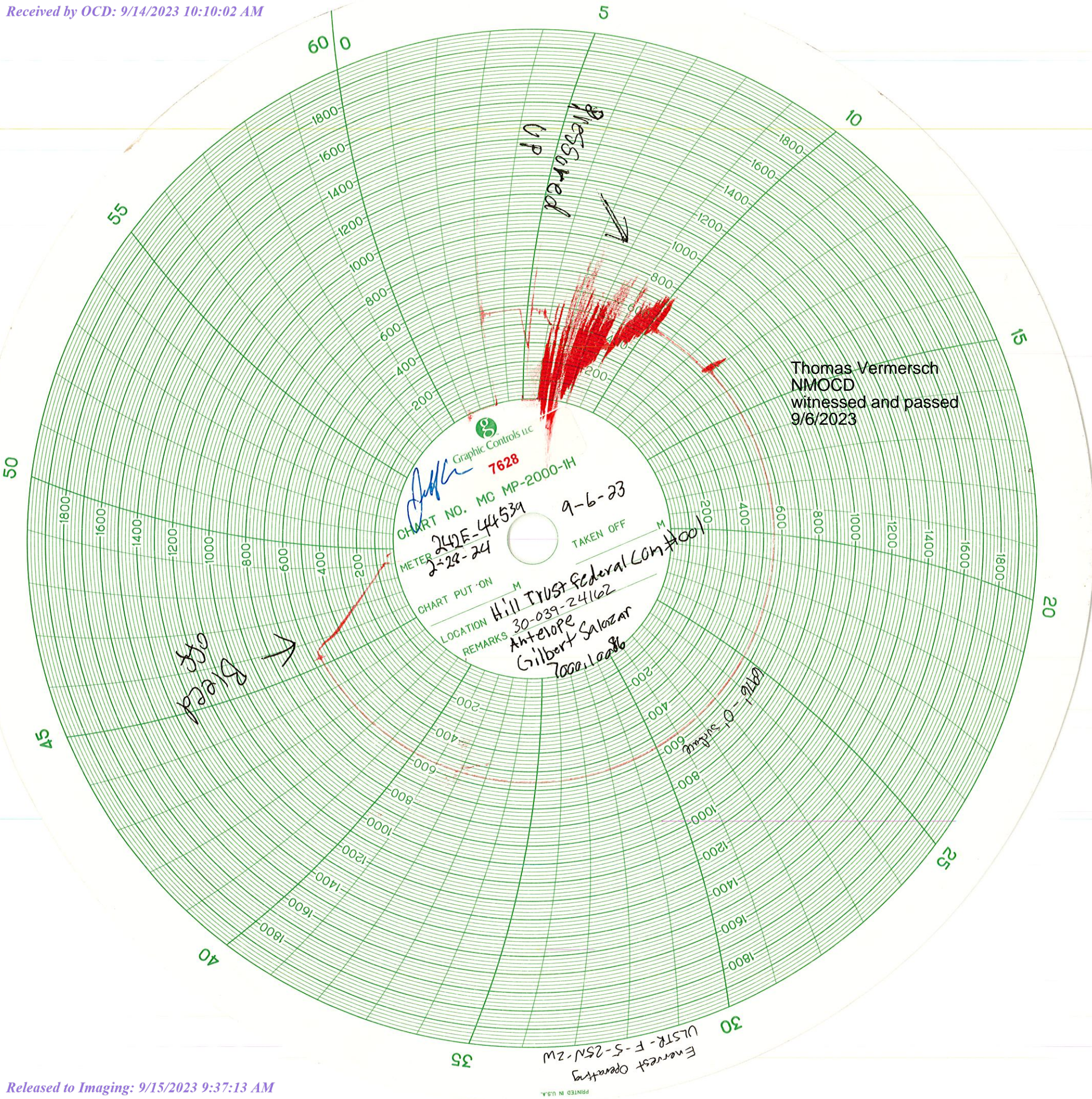

SCOPE OF WORK

06/12/2023: MIRU. Pulled 240 jnts of tubing. RIH with 4.5 OD gauge ring to 6986'. Casing showing as clear. POOH with gauge ring tools. PU RIH with 4.24" OD plug set CIBP @ 6976'. Set with 10 gals of sand in tubing. RIH with 120 jnts tubing. Secured well.

06/13/2023: RIH with 102 jnts tbg for a total of 222 jnts. Load hole with 155 bbls of water. Circulated 30 bbls out of casing. Pressure tested casing to 545 PSI. Held for 15 minutes. POOH with tbg. Top off casing with 25 bbls fluid. Pressure test to 570 PSI. Good Test. Rig down.

06/14/2023: hook up test equipment. Conduct Bradenhead test. Pressure well to 590 PSI for 30 minutes. Rig down test equipment. MIT was witnessed by Thomas Vermersch. No paperwork was given to the foreman on-site.
