I. Objectives

The long-term objective of reclamation and remediation is to set the course for eventual ecosystem restoration, including the restoration of the natural vegetation community, hydrology, and wildlife habitats. In most cases, this means returning the land to a condition approximating or equal to that which existed prior to the disturbance. The operator is generally not responsible for achieving full ecological restoration of the site. Instead, the operator must achieve the short-term stability, visual aesthetic, hydrological, and productivity objectives of the Bureau of Land Management and take the steps necessary to ensure that long-term objectives will be reached through natural processes.

II. Background

The surface owner is Bureau of Land Management per the Eddy County Assessor's Office (Sidwell's Portico).

III. Scope of Work

1. There will be no reclamation work on the drilling pit.
2. Any remaining surface materials, deep bury 4' at the point designated on the diagram.
3. Rip the well pad east to west, or follow the natural sloping. Ditch cut along east entry, north and west edge of pad, 725' X 2' X 2', (See Diagram).
4. The reclamation site was broadcast seeded on, with the below seed mixture per the surface owner (see table below). A 500' radius trash sweep must be conducted with all trash removed.

Mix	Species	lb/acre (Drilled)	lb/acre (Broadcast)
BLM #1 (For Loamy Soils)	Plains lovegrass	1.0	2.0
"	Sand dropseed	2.0	4.0
"	Sideoats grama	10.0	20.0
"	Plains Bristlegrass	4.0	8.0

Weights should be as pounds of pure live seed.
