7/24/18–7/30/18 - RIH with tubing and tagged at 7200'. Tally of tubing showing fish top to be at 7195'. Set 1 pt and rotate to latch onto fish. Started running in and tagged solid at 7225'. Set down 5 pts tried to rotate over fish. TOH and recovered 16" of 2-7/8" tubing. Tubing is paper thin and broke off at the mill control below the grapple. Tagged fish top at 7225'. Tried to rotate and work over fish. Worked down to 7228' and could not make any progress past 7228'. Did not recover fish. Ran 5-1/2" lead block on sandline. Shows markings on the center of lead block that look like a piece of 2-7/8" tubing with a folded in piece. TIH and tagged fish top at 7228'. Rotate and work fish down to 7232'. Did not gain any weight when picking up. Tried to work over multiple times. No weight gained. Tagged fish top at 7232'. RU swivel and mill down to 7268'. Bottomed out on top bushing. Shoe and wash pipe would run free from 7232'-7260' without rotating or pumping. Did not recover fish. Tagged fish top at 7252'. Screw into fish. Worked 15K over string weight. Worked to release TAC, no success. Fish had a 1 pt drag coming out of the hole. Recovered 23' of 2-7/8" tubing. Bottom piece was really thin and broken. Had 4' tubing wrapped on OD from cutting over with shoe. Tagged fish top at 7258'. Tried to screw into fish with no success. Did not recover fish. Opened up well and no pressure on casing. Tagged fish top at 7260'. Washed over fish from 7260'-7281', drilled at 7281' for 1 hour and 15 minutes with no progress. TIH with tapered box tap with 5-1/2" x 1-1/2" tapered catch. Tagged at 7281' and worked down to 7286'. TIH and tagged fish at 7289' rotate and screw into fish top. Worked down to 7290'. 5K drag coming up to 2'. Went back down and tried to screw into fish again. Did not recover fish. Markings inside box tap show fish went to the 5-1/4" ID section and came loose. Top of fish at 7290'. Ran in hole with production tubing and set at 7265', 25' above fish top. ND BOP.
