Procedure Description: Mack Energy Corporation is requesting a change to the Cold Lake Federal #1H APD. Mack Energy Corporation plans to drill a pilot hole to 3,500'. Open hole logs will be ran and sidewall cores will be taken. After the wellbore is log and cores are taken, set a Isolation cement plug from 3,500' up to 2,200' w/ 560sx Class C cmt density 14.8, yield 1.32, cmt kick off plug will be set from 2,200' up to 1,500' w/ 390sx Class H cmt density 17.5 yield .94. After logs and cores the well will be plugged back and continue as a horizontal well.
