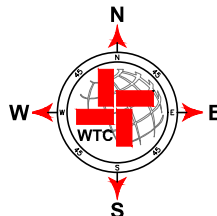


CARLSBAD, NM IS ±15 MILES TO THE SOUTHWEST OF LOCATION.

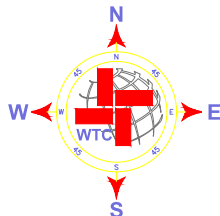


FOUR MILE DRAW #3H

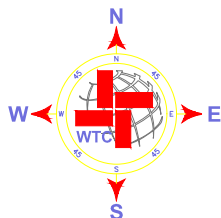


FOUR MILE DRAW #3H
