Actual Procedure: 4/19/2022: Test BOPS. Drill 9.875 intermediate hole to 2047 ft. 4/20/2022: Run 9.875 inch 40 lb J-55 intermediate casing to 2033 ft. Pump 20 bbls chem wash, 20 bbls vis spacer, followed by 187 sks of 11.5 ppg lead cmt, 414 sks of 14.8 ppg tail cmt. Drop plug and displace with 151 bbls of fresh water. 50 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test. 4/21/2022: Drill 8.75 inch production hole to 8290 then switch to 6.75 inch to 18877 ft. 5/1/2022: Run 5.5 inch 20 lb P-110 production casing to 18634 ft MD. Pump 20 bbls chem wash, 20 bbls vis water, then 595 sks of 10.5 ppg lead and 840 sks of 13.2 ppg tail cmt. Drop plug and displace with 20 bbls sugar water and 397 bbls brine. 40 bbls gel spacer returned to surface. Est TOC at 0 ft.
