- ¹ Methane Calculation: 717 grams CH4 per cubic meter (717 x 0.2823 m3/day = 202.41 g/day total /24 = 8.43 g/hour x 0.097081 (methane concentration) = **0.82 g/hour CH4**). **Methane, gas** weighs 0.000717 gram per cubic centimeter or 0.717 kilogram per cubic meter, i.e. density of methane, gas is equal to 0.717 kg/m³; at 0°C (32°F or 273.15K) at standard atmospheric pressure. In Imperial or US customary measurement system, the density is equal to 0.044 pound per cubic foot [lb/ft³].
