Re: Notification and Verification of a Standard Well Location for the Hawk 35 Fed 103H (30-025-48088), Sec 35, T24S, R33E, Lea County, NM

Dear Mr. Lowe:

Included with this letter are the following documents demonstrating that the above referenced well will be drilled at a standard oil well location:

- C-102 Plat dated October 3, 2023, showing the proposed location of the Hawk 35 Fed 103H, respectively;
- "Area of Common Ownership Plat" separately showing the spacing units for the well; and
- Certification of Ownership demonstrating the outlined area on the plat is comprised of one federal lease, with uniform ownership.

19.15.16.15.C(7) NMAC provides that in area of common ownership (here, one federal lease) the setback requirements only apply to the outer boundary of the area of uniform ownership, not the spacing unit within the area of uniform ownership. Since the area to the west towards which this well encroaches is within the documented "area of common ownership," this well is at a standard location and approval of a non-standard location for the well is not necessary.

Please place this Notification and Verification of a Standard Well Location in the well files for Hawk 35 Fed 103H (30-025-48088).

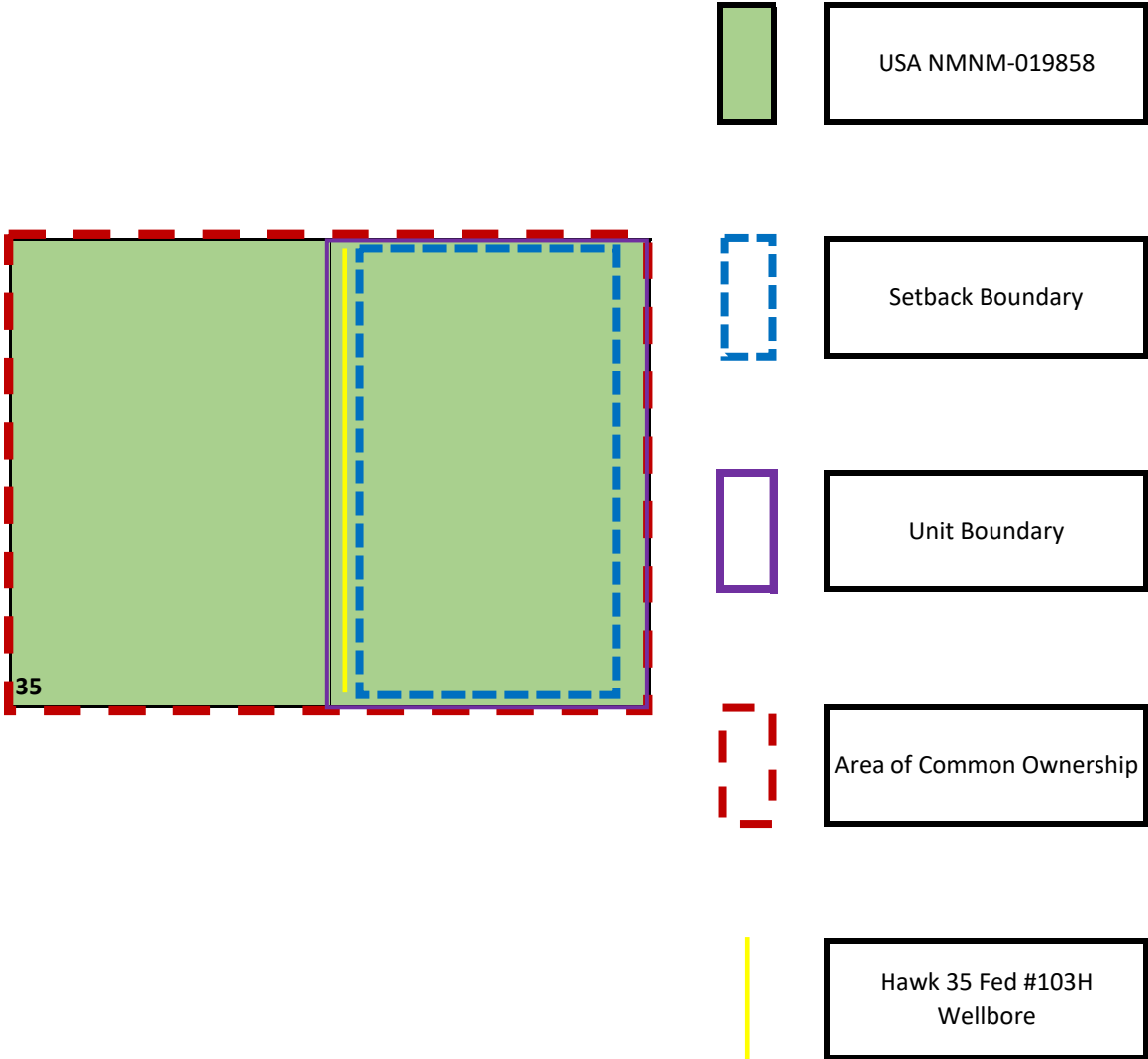
