Pump 20 bbls water spacer, followed by 471 sks of 14.8 ppg tail cmt. Drop plug and displace with 43 bbls brine. 2 bbls of cement returned back to surface with top job. EST TOC at 0 ft. Pressure test casing to 1500 PSI for 30 minutes, good test. 3/7/2023: Test BOPS. Drill 9.875 intermediate hole to 8526 ft. 3/10/2023: Run 7.625 inch 29.7 lb P-110 intermediate casing to 8469 ft.
