Procedure Description:	<p>It appears that someone had backed into the wellhead on this location, causing damage at the surface. The BLM and NMOCD were notified. Verbal approval was received to move a rig onto location and perform immediate repairs to the wellhead and isolate the perforations, until such time as a permanent plugging and abandonment design could be submitted and approved by the regulatory agencies.</p> <p>March 19, 2021: Shut in pressures were noted as follows: SICP=20 psi. SITP=20 psi. SIBHP= 0 psi. ND wellhead. Held JSA and filed hot work permit. Repaired damaged wellhead by welding a casing patch at surface. NU BOP. LD 34 jts. of 2-3/8" tubing.</p> <p>March 22, 2021: TIH with mill and 34 jts workstring. TOOH. TIH with cement retainer and set at 1070' to isolate perforations. Rolled hole and PT casing to 600 psi, did not test. TOOH. ND BOP. NU wellhead. Engineering is preparing a NOI for permanent plugging and abandonment of this well.</p>
