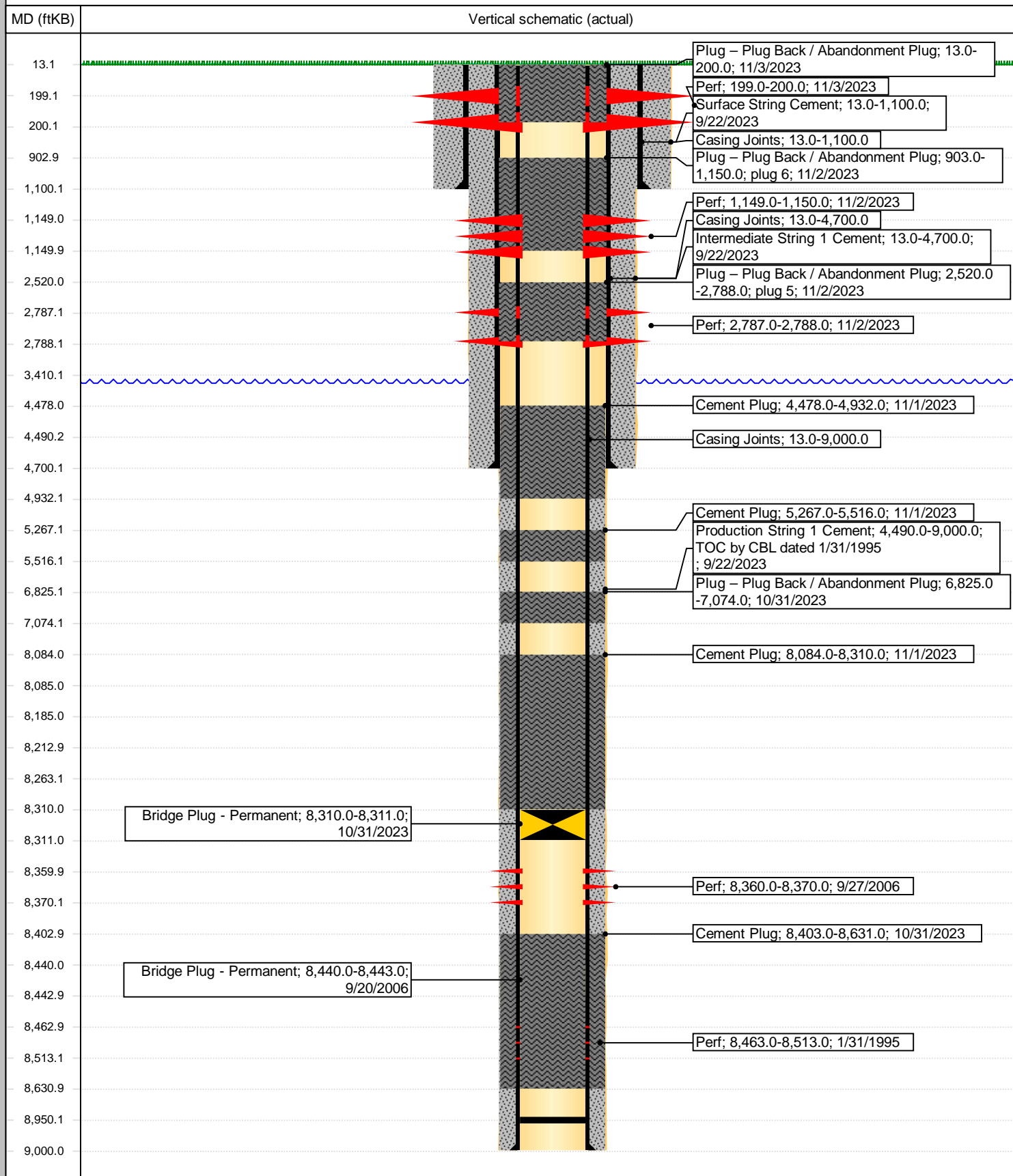




CURRENT SCHEMATIC **PROHIBITION FEDERAL UNIT 4**
