Written Statement for APD Extension Request

Permian Resources Operating, LLC respectfully requests an extension to the Romeo Federal Com 111H (30-025-50261) and the Romeo Federal Com 112H (30-025-50262) APDs. The reason these wells were not drilled within the first two years of approval is due to a merger in the later part of 2022 and an acquisition in the later part of 2023 that caused significant changes to the drill schedule. The need by date is March 1, 2024.

## **CONDITIONS OF APPROVAL FOR APD EXTENSION**

The Approved Application for Permit to Drill (AAPD) expires if only conductor or surface casing has been set, and the well is not being diligently drilled at the expiration date of the extension.

The APD extension is granted for a 2-year period, not exceed 4 years from the approval of the APD.
