Procedure Description: Matador Production Company respectfully requests that the Bureau of Land Management approve the extensions of the Applications for Permits to Drill (“APD”) referenced herein. MPC obtained these APDs from Ascent effective December 2021. MPC is currently drilling and completing eight wells on the Pony Express project and is scheduled to begin production flow back at/or around 4/7/23. MPC believes it would be best practice to monitor the production from these well in order to inform how MPC should continue its development of this project. As a result, a 24-month extension is requested to prudently develop the remainder of the Pony Express project and reduce waste. MRC is scheduled to return to drill the Pony Express project in Q1 2025.
