Procedure Description: Matador Production Company respectfully requests that the Bureau of Land Management approve the extensions of the Applications for Permits to Drill ("APD") referenced herein. MPC is currently drilling and completing eight wells on the Pony Express project and is scheduled to begin production flow back at/or around 4/7/23.
