MU and TIH with 4 ½" cement retainer, set retainer at 1031'. Load and roll hole. PT casing, did not test.

P&A Plug 1: Fruitland Coal perforations, Fruitland formation top: Mix and pump a plug of 59 sx, (12 sx through retainer and into Fruitland perforations, sting out and place 47 sx above retainer). TOOH. WOC.

12-12-2023:

TIH, tagged Plug 1 at 446'. PT casing, did not test.

P&A Plug 2: Kirtland and Ojo Alamo, formation tops to surface: Mix and spot a balanced plug of 37 sx from 446'. TOOH. ND BOP, Tagged Plug 1 in 4 ½" casing at 45'.

Cut off WH. TOC at 22' in 7" casing. Install P&A marker.

P&A Plug 3: Top off casings and cellar with 24 sx.

All cement used was Class G mixed at 15.8 ppg, yield 1.15 cu ft/sx.

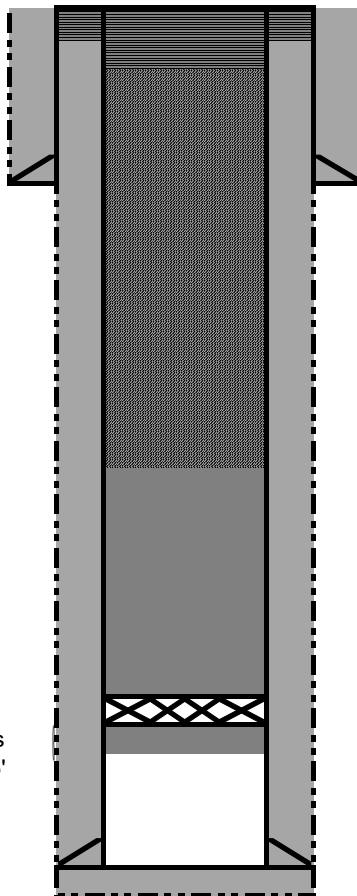
