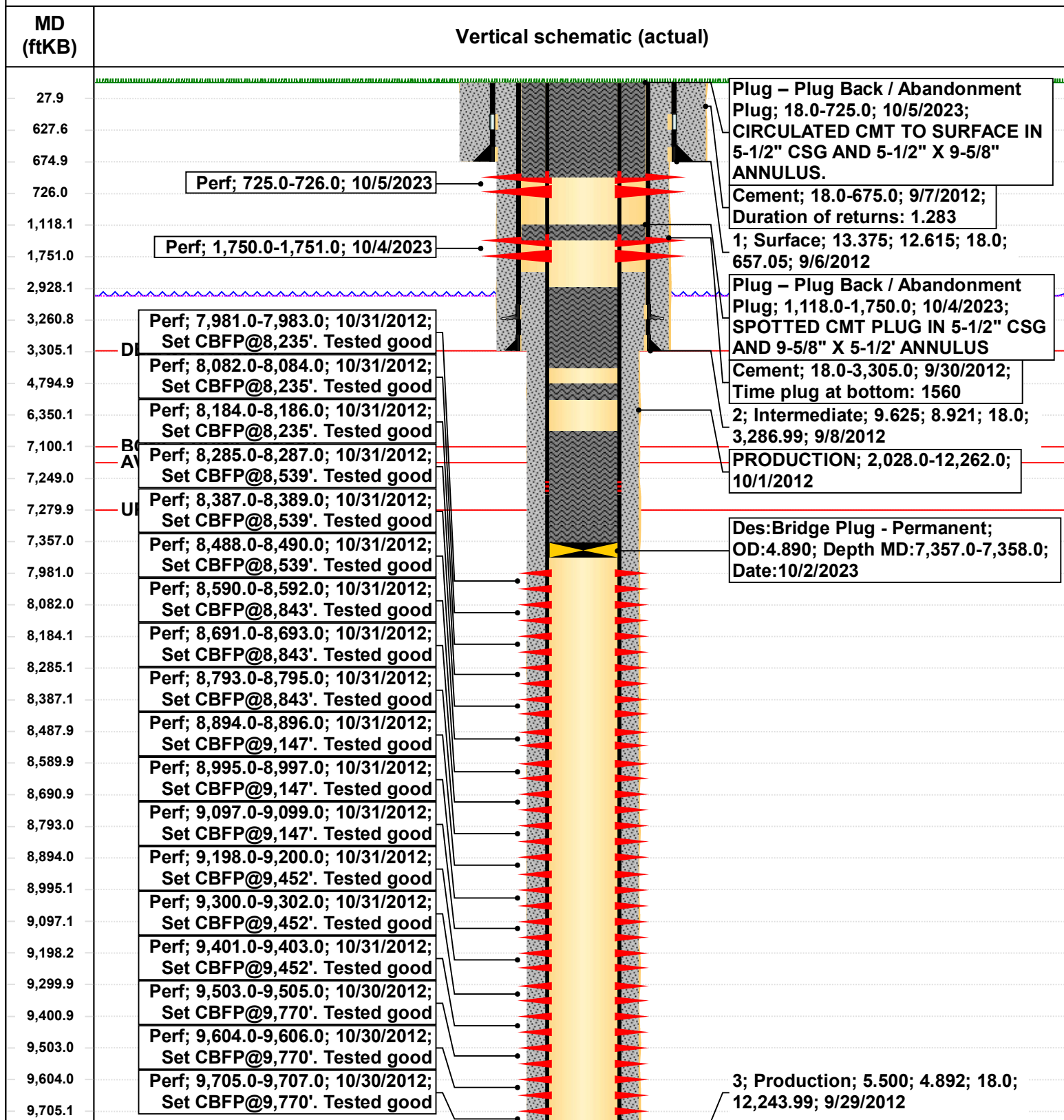


Schematic - Current
