**Procedure Description:** Matador Production Company respectfully requests that the Bureau of Land Management approve the extensions of the Applications for Permits to Drill ("APD") referenced herein. MPC obtained these APDs from Ascent effective December 2021. MPC drilled two wells on the Silver project in 2022 and is scheduled to spud an additional six wells in June/July of 2023. MPC believes it would be best practice to drill and complete the currently scheduled batch of Silver wells and monitor the production from these new wells in order to inform how MPC should continue its development of this project. As a result, a 24-month extension is requested to prudently develop the remainder of the Silver project and reduce waste. MRC is scheduled to return to drill the Silver project in Q1 2025.
