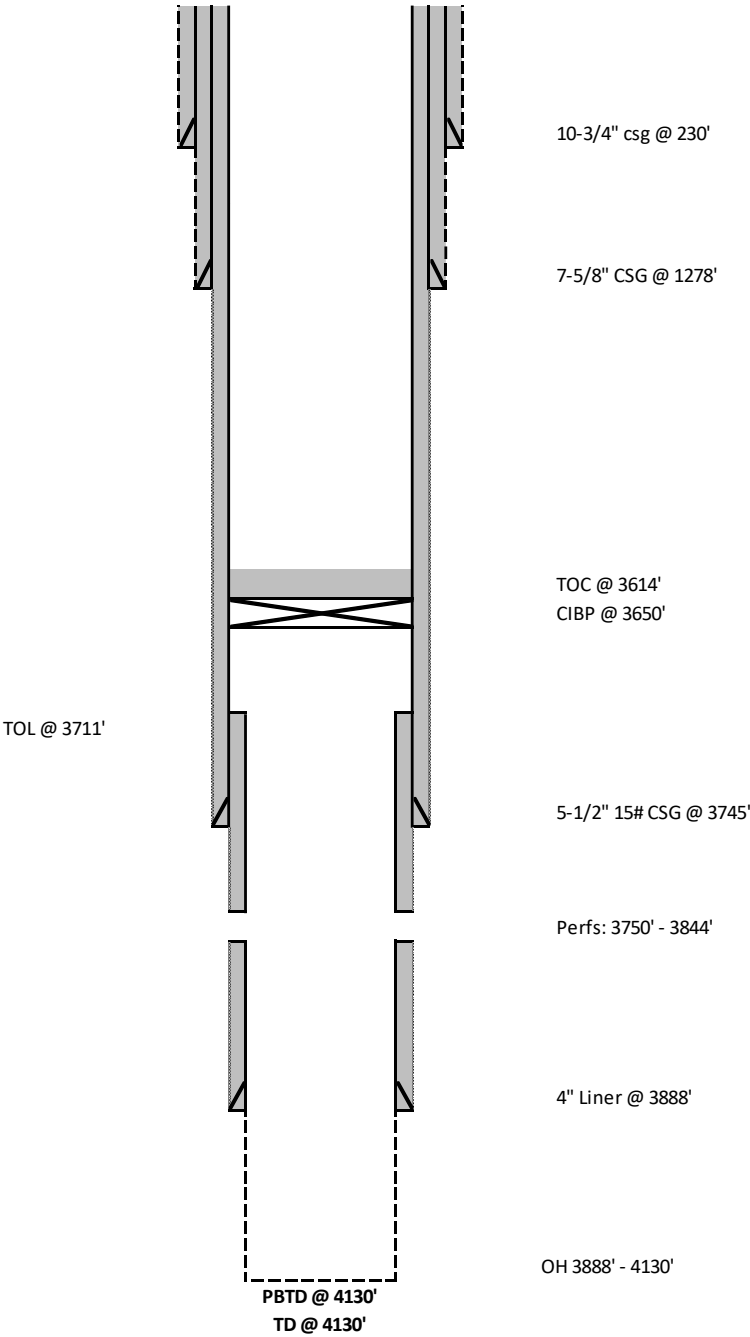

Pressure held. MIT passed.

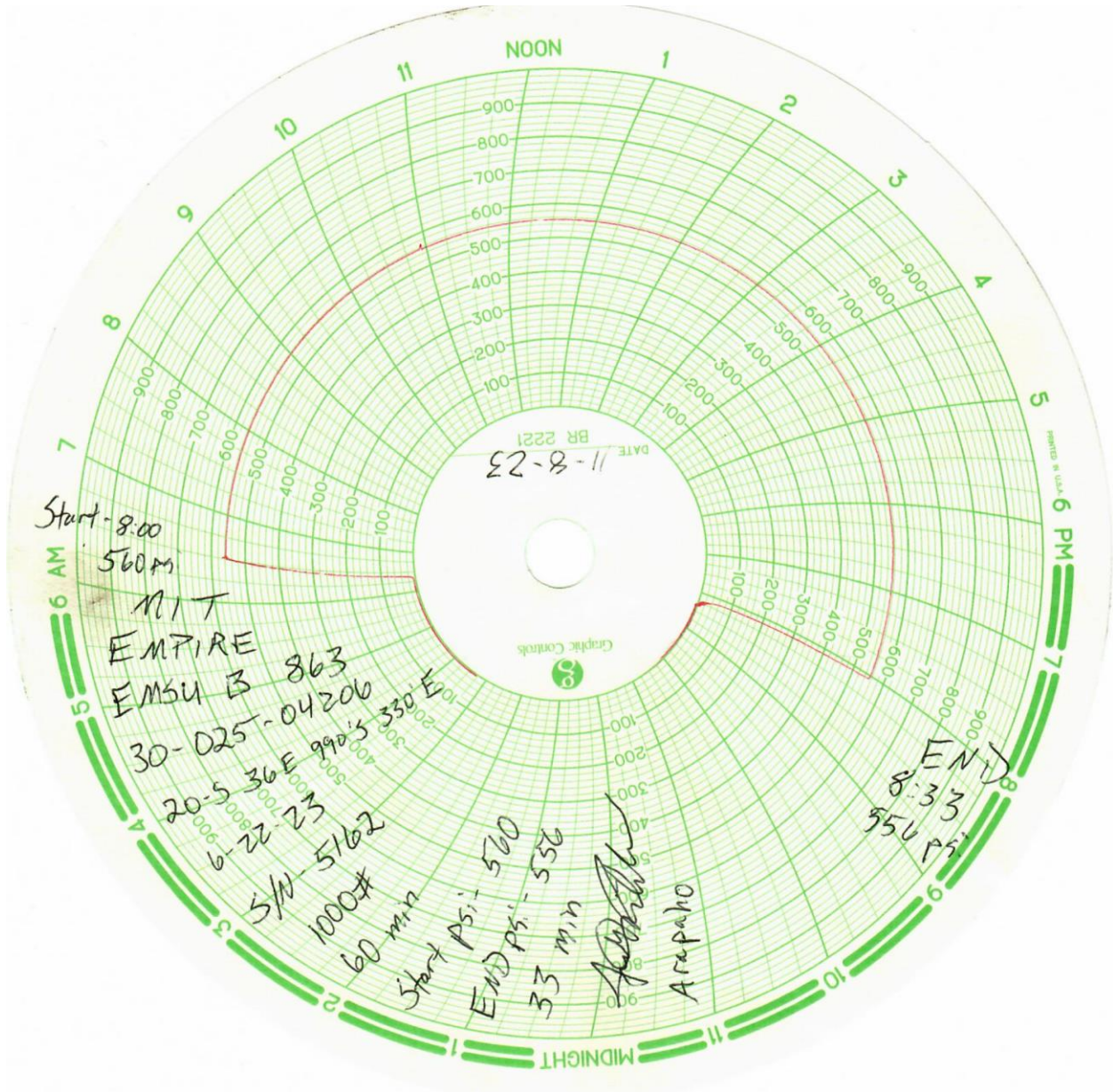
