Good afternoon Monica and Kenny,

Attached is the CBL run this morning (4/2/2024). The log shows TOC @ ~62'. Surface casing shoe is at ~133'.

Additionally, the following was performed/discovered:

- Pressure tested the 4-1/2" casing above the CICR to 560 psi (Good Test).

Moving forward, Hilcorp received verbal approval from the NMOCD for the following adjustments to the approved NOI (attached):

- PLUG #1: 109sx of Class G Cement (15.8 PPG, 1.15 yield); FRD Perfs @ 1,456' | KRD Top @ 309' | Surf. Casing Shoe @ 133':
 - Pump a 109 sack balanced cement plug inside the 4-1/2" casing (est. TOC @ +/- 0' & est. BOC @ +/- 1,394').
 - RIH w/ 1" polyline in the 4-1/2" Casing x 7" Casing annulus, circulate cement to surface.
 - Top off as needed

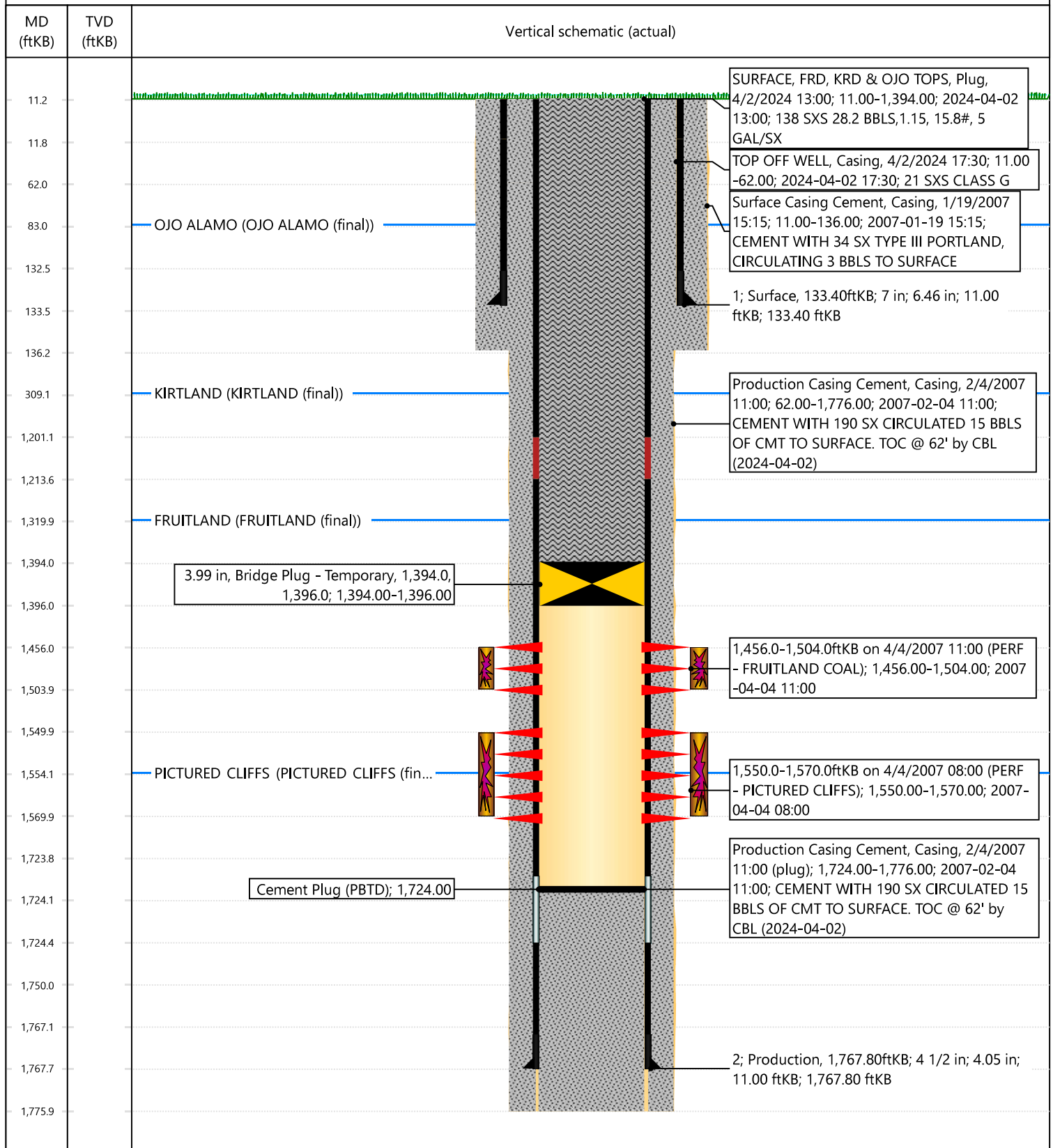


Current Schematic - Version 3
