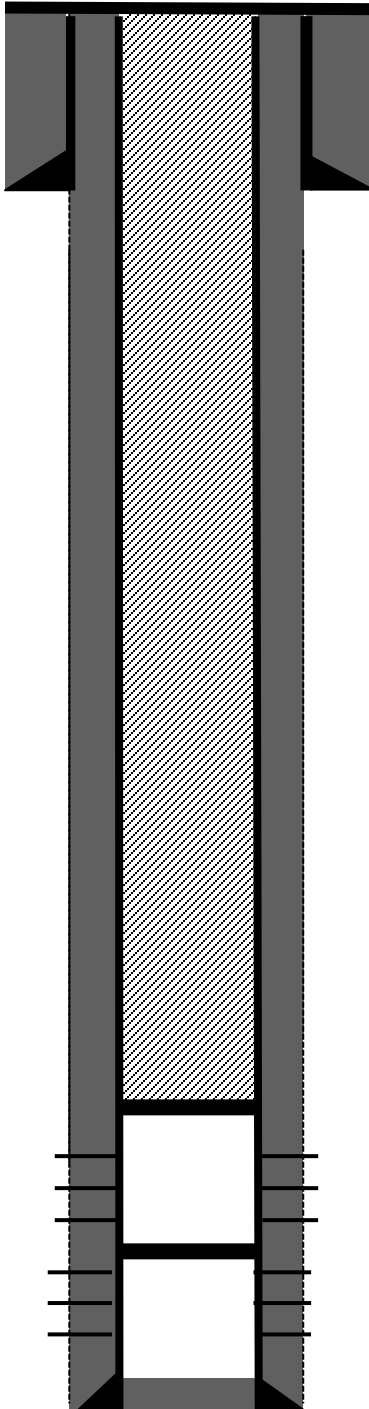

Dugan Production P&A'd the well on **03/25/2024 – 03/27/2024** per the following procedure:

- MI&RU Dugan Rig 108. Check pressures, Tubing 0 psi, Casing 0 psi, BH 0 psi.
- LD rods and 2-3/8" production tubing. PU & tally 2-3/4" tubing for workstring.
- Run 4½" string mill to 1150'. RIH & set 4½" CIBP @ 1116'. Fruitland Coal perforations @ 1160'-1176'.
- Load hole & circulate w/23.5 bbls water. Attempt to pressure test casing to 650 psi for 30 mins. Casing tested good. Test passed.
- Spot inside Plug I above CIBP @ 1116' w/98 sks (112.7 cu ft) Class G neat cement to surface to cover the Fruitland-Kirtland-Ojo Alamo tops (5 gal/sk, 15.8 #/gal, 1.15 cu ft/sk). LD all tubing. WOC overnight. Check pressures, Tubing 0 psi, Casing 0 psi, BH 0 psi. Cut wellhead off. Tagged TOC @ 42' inside annulus and 0' inside 4½" casing. Good tag. **Plug I, inside 4½" casing, 0'-1116', Fruitland-Kirtland-Ojo Alamo, 98 sks, 112.7 cu ft.**
- Fill up cellar and install dry hole marker w/20 sks, 23 cu ft Class G cement.
- Clean location. Rig down Dugan Rig 108. Clay Yazzie w/Farmington BLM Field Office witnessed job.
- **Well P&A'ed 03/27/2024.**

Based on the CBL, the top of cement appears to be at 50' from surface. We request the following revisions on the original approved procedure.

1. Fill up inside 4 ½" casing from CR setting depth at 1110' to surface as one plug, **Plug I**.
2. WOC and cut wellhead off and tag TOC.
3. Fill up annulus, casing, and cellar from surface.

Please let us know if the revised proposal is acceptable to NMOCD/BLM and we will proceed accordingly.
