Cement with Type I-II, 20% flyash, 31.2 bbls (109 sx) 14.6 ppg, 1.61 yield, 7.41 gps. Drop plug. Displace with 24.53 bbls of water. Bump plug at 400 psi & hold for 5 min. Check floats, floats held. Circulate 8 bbls good cement back to surface. TOC: surface BOC: 365. RDMO.
