1. Move in rig up.
2. Pull production equipment.
3. Troubleshoot well and identify source of bradenhead pressure.
4. Shoot perfs and squeeze cement.
5. Drill out cement.
6. Run production equipment.
7. Return well to production.

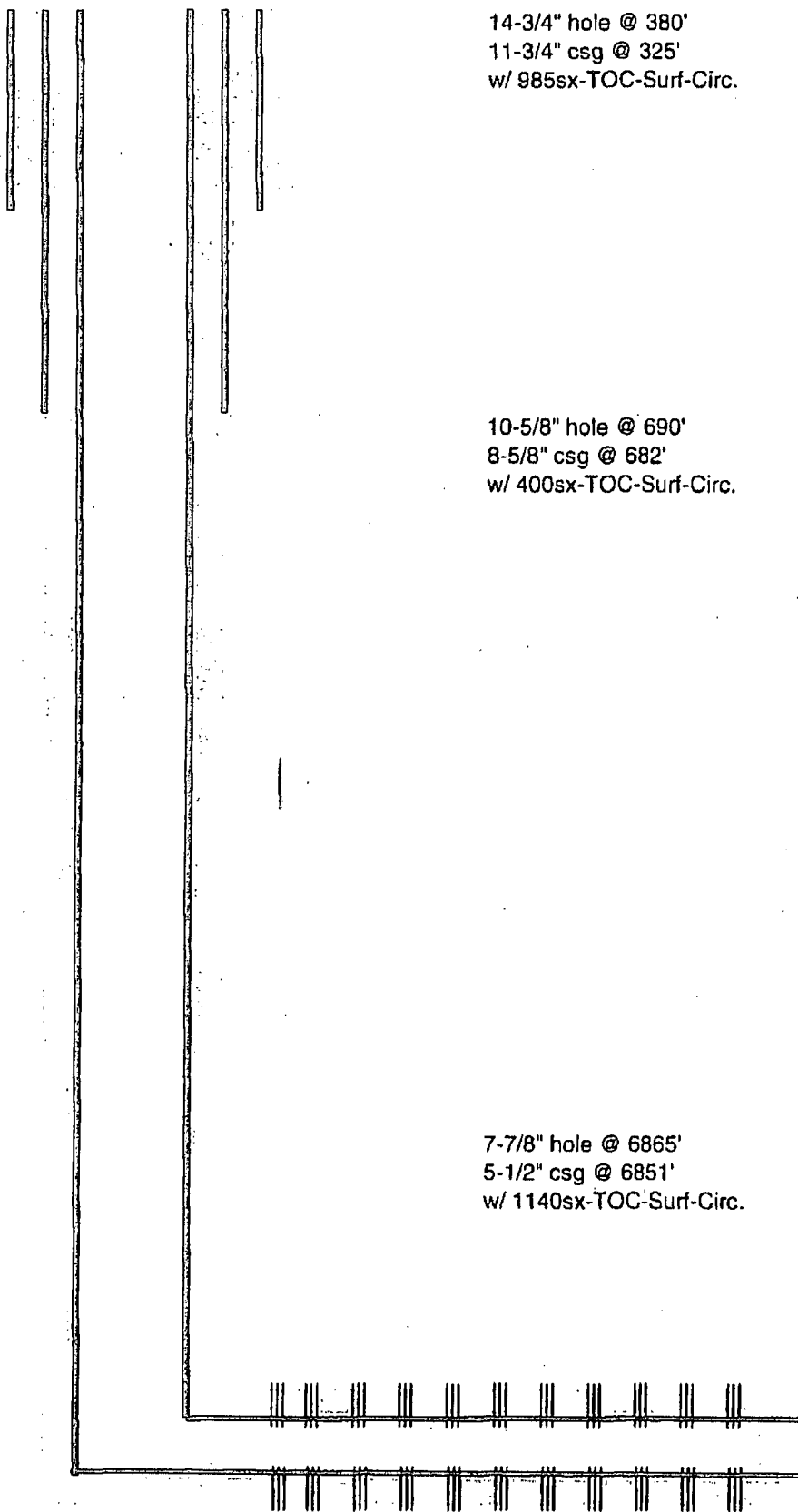
