RU Hot Oil trk, pumped 2 drums Xylene, followed by 20 bbls hot oil. RU, pumped 50 bbls. Pressuring at 3000 psi. Swithced back to csg, Pumped 35 bbls. RU on tubing. RIH with rods, tagged at 3025'. POOH with rods. RU hot oil truck and pumped 45 bbls hot oil & 40 bbls hot water to clean tubing. POOH with tubing. Tally tools, RIH with tubing. Tested tubing in hole to 7000#. Change out TAC. RIH with tubing. ND BOP, set TAC, NU WH. RIH with rods. Pumped 20 bbls, load well test to 600 psi, held good. Rigged down well servicing equipment and cleaned location. Returned well to production on 4/8/2024.
