Replace tubing as needed from visual inspection. 7. Pick up reconditioned or new packer and run in hole on the tubing while testing the tubing below the slips to 4500 psi (test tools to be coated). Replace tubing as needed. 8. Once on depth above perforations, circulate in packer fluid (corrosion inhibitor and biocide) mixed in fresh water. 9. Set packer. ND BOP and NU wellhead.
