Procedure Description: Intent to P&A this well. Notify BLM and NMOCD prior to starting plugging operations. MJRU, NU BOP. Clean out well (2-7/8" 6 .4# Casing x 5-1/4" hole set @ 2674', cemented w/ 265 sxs, est. TOC 1075'). Set CIBP @ 2462'. Attempt to pressure test casing to 500#. If casing does not test, spot or tag plugs as necessary. Mix and pump 17 sxs Class G Cement from CIBP @ 2462'. Perf 2-7/8" Casing @ 174' (7" 23# casing x 9-3/4" hole set @ 124' with 100 sxs Cement, Circulated to surface). Mix and circulate 42 sxs Class G cement to surface out all Annuli. Cut off WH. Install 4" diameter 4' tall Above Grade P&A marker. Top off as necessary. Record Long/Lat. Note: 50' excess cement required for inside. Note: 100% cement excess to be used inside open hole .5

CONDITIONS OF APPROVAL

1. Plugging operations must be completed by September 1, 2024.
2. Plugging operations authorized are subject to the attached "General Requirements for Permanent Abandonment of Wells on Federal and Indian Lease."
3. No reclamation plan on file. Operator is required to schedule a pre-reclamation onsite with BLM surface staff prior to submitting a reclamation plan for review and approval. Final reclamation earthwork must be completed within 6 months of well plugging.
4. The following modifications to your plugging program are to be made:
 - a. Add an inside/ outside plug for the BLM formation top pick for the Nacimiento located at 1040'. Contact the BLM Farmington Field Office if cement cannot be placed outside of the casing.
5. Farmington Office is to be notified at least 24 hours before the plugging operations commence at (505) 564-7750.

You are also required to place cement excesses per 4.2 and 4.4 of the attached General Requirements.

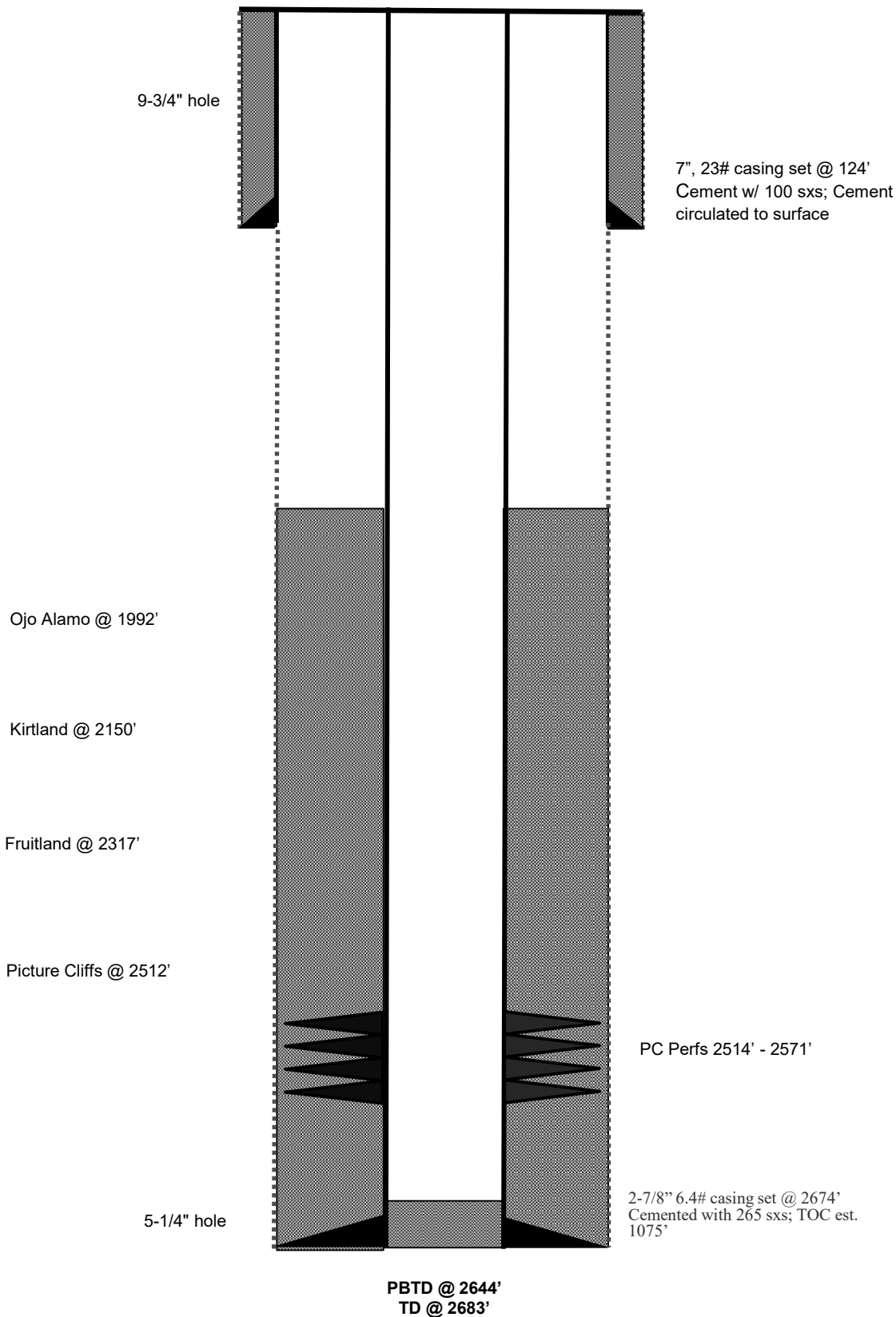
