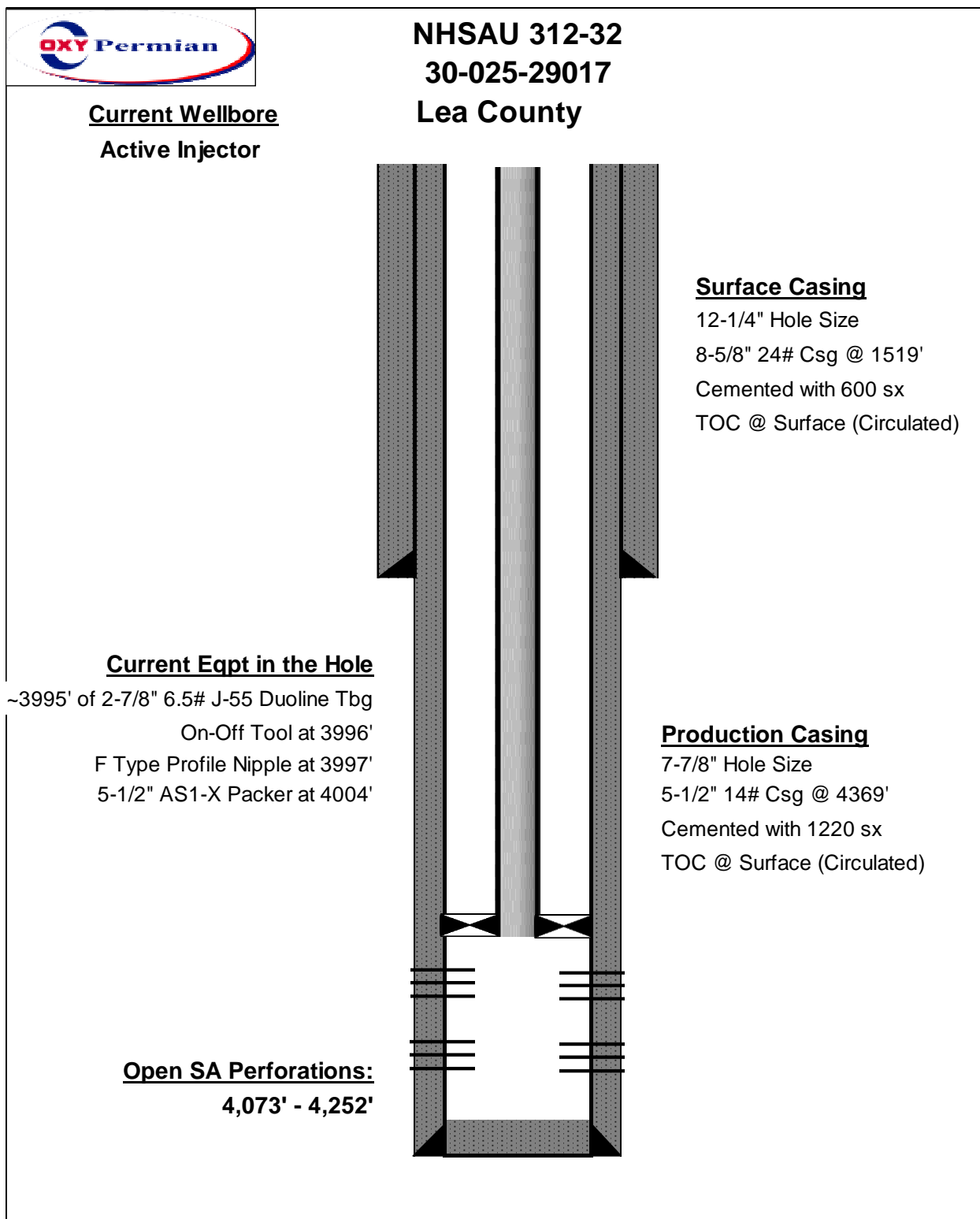

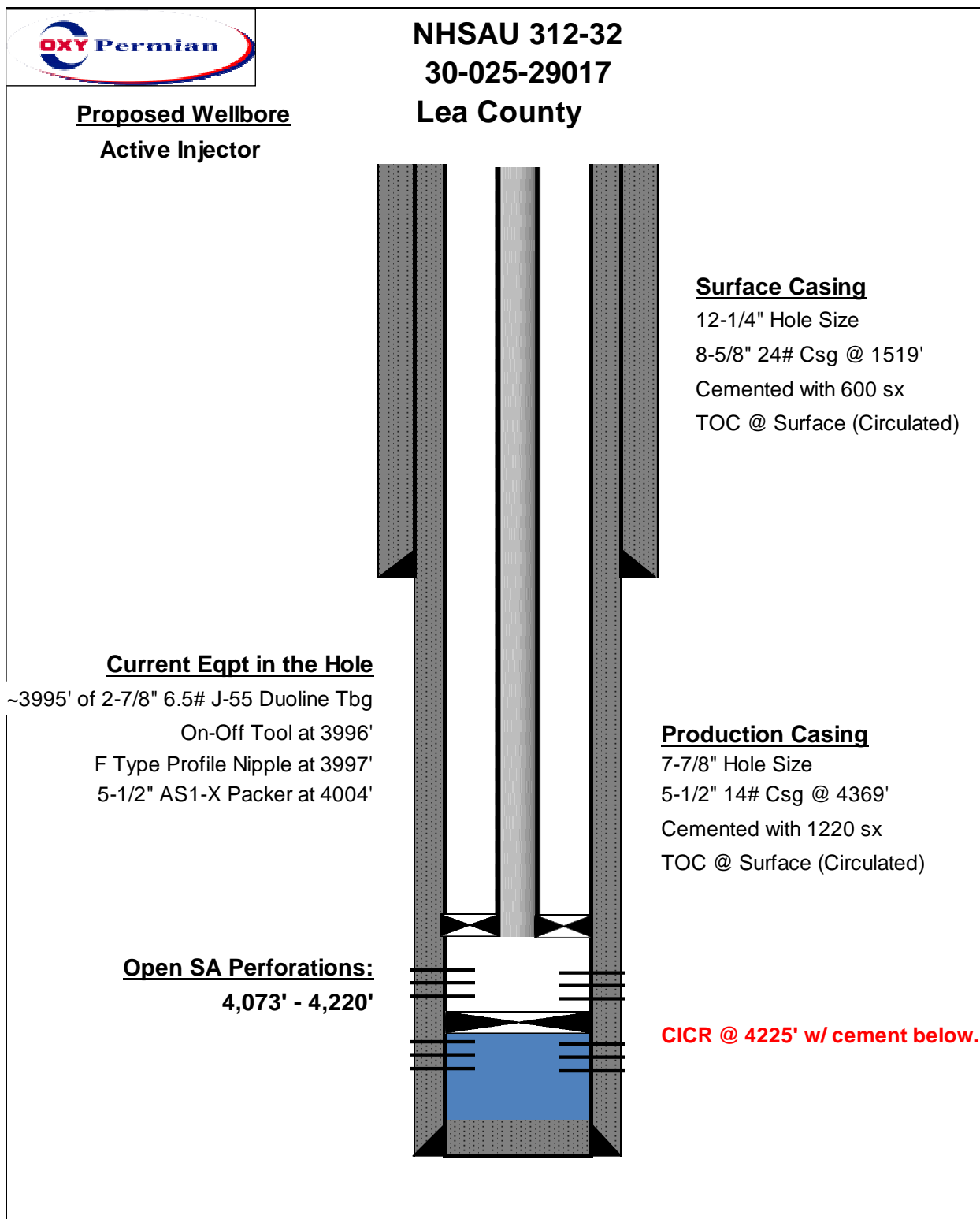

- 1) MIRU PU
- 2) POOH w/ injection equipment
- 3) RIH w/ CICR & set at 4225'
- 4) Cement squeeze bottom clusters of perforations
- 5) PU 4-3/4" bit & CO to PBTD of ~4230' x POOH w/ bit
- 6) RU WL x Reperforate wellbore if needed x RD WL
- 7) RIH w/ 5-1/2" PPI tool (if needed)
- 8) Acid stimulate well with ~4,000 gal 15% HCL (if needed)
 - Max rate = 4-5 BPM
- 9) Flush acid with ~200 bbls off fresh water
- 10) POOH LD PPI tool
- 11) RIH w/ injection equipment
- 12) RD PU. Return well to injection.
